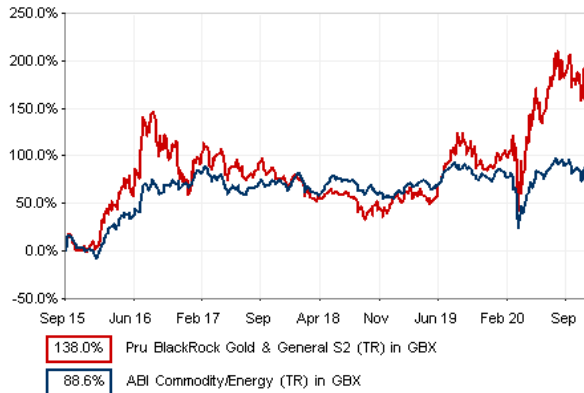

Objective: The investment strategy of the fund is to purchase units in the BlackRock Gold & General Fund - the underlying Fund.

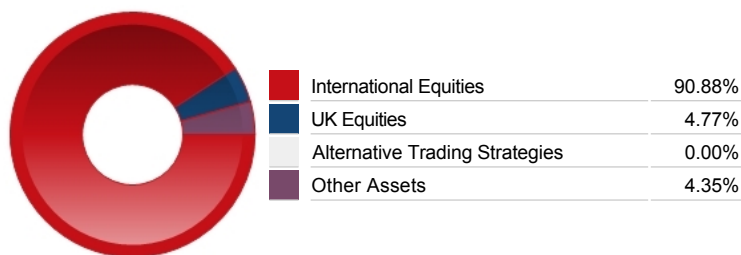

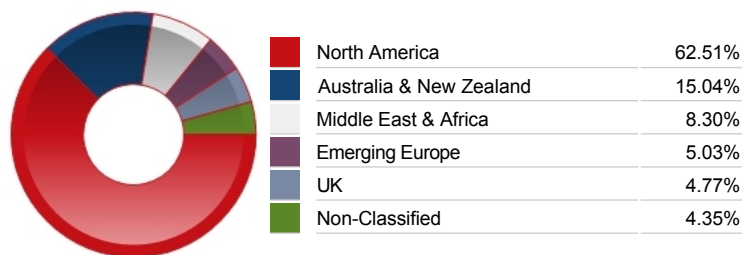

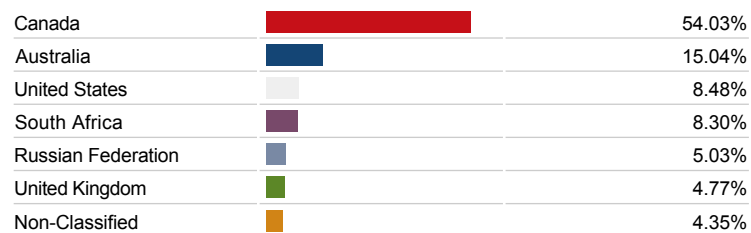
**Regional Allocation**



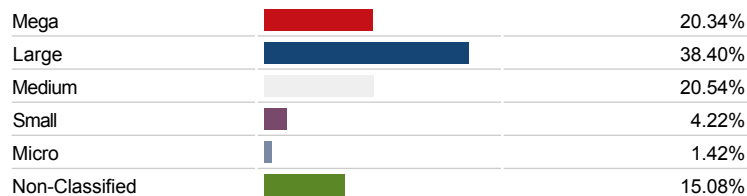
**Equity Sector Breakdown**
