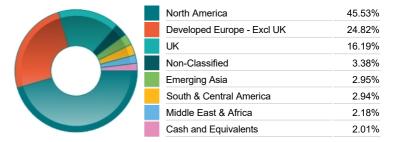

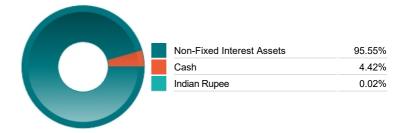
Regional Allocation
