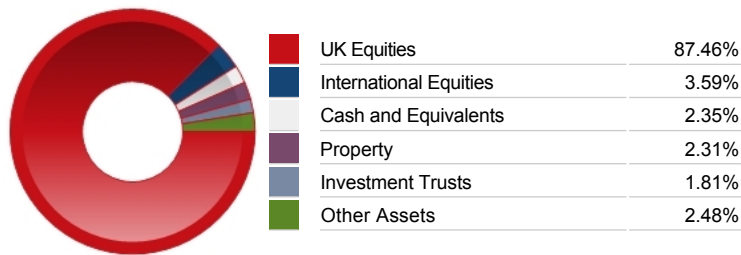

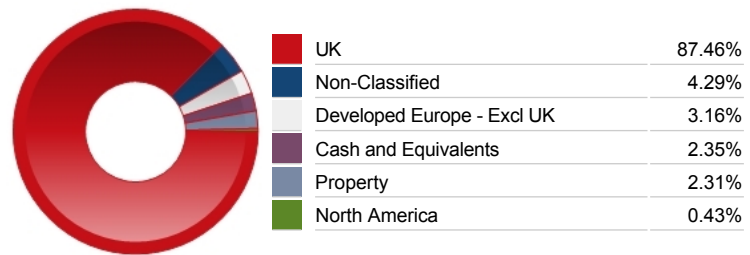

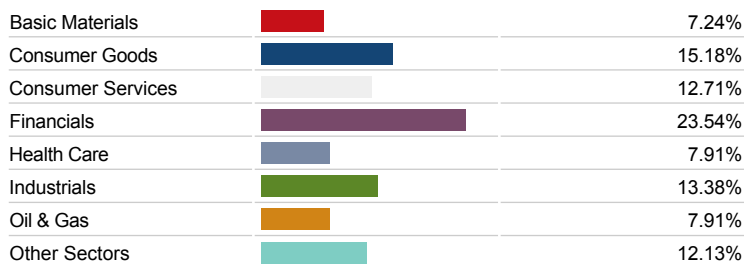
Asset Allocation



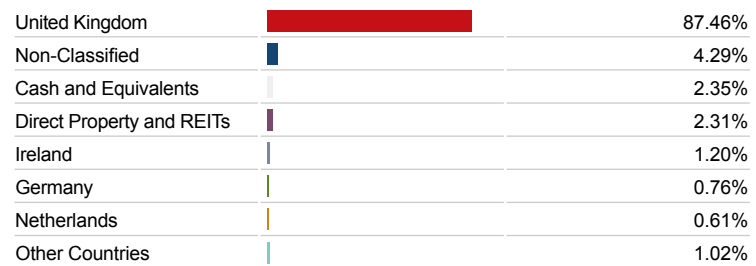
Regional Allocation



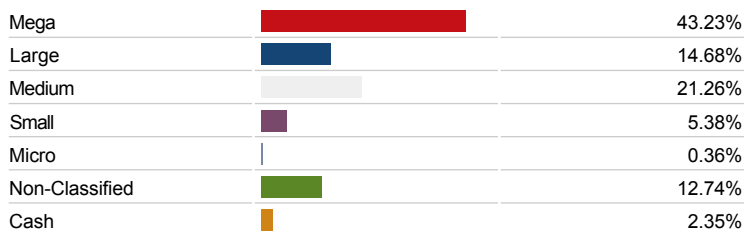
Sector Breakdown
