Commentary

Performance as at Q4 2023 - The fund's overweight position in more recently issued higher yielding 4 year maturity bonds performed strongly against bonds of similar maturity contributing positively to the fund's performance. At the end of the quarter the manager tactically reduced duration exposure due to the strong rally in fixed income. This had a small positive contribution to fund performance over the quarter. The fund is remains underweight 7/10 year fixed rate gilts versus the wings. The is tactically short duration versus the benchmark. Activity in the fund continued to focus on an active stock specific relative value approach. The manager continues to position in the fund in anomalously cheap securities along the gilt yield curve.
