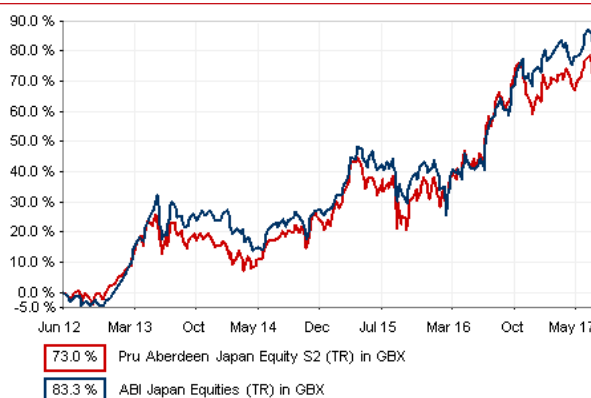

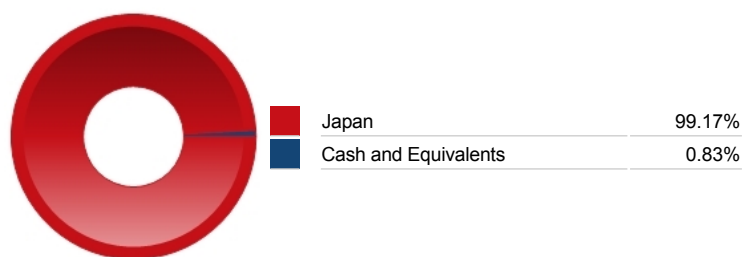

Regional Allocation



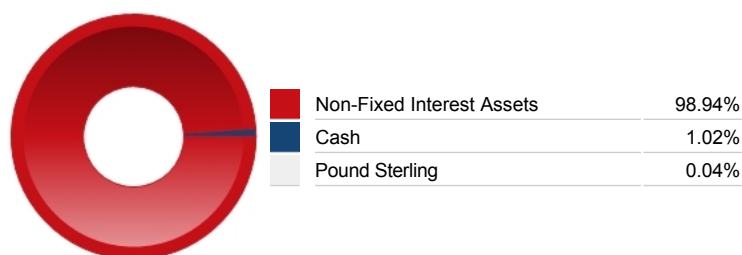
