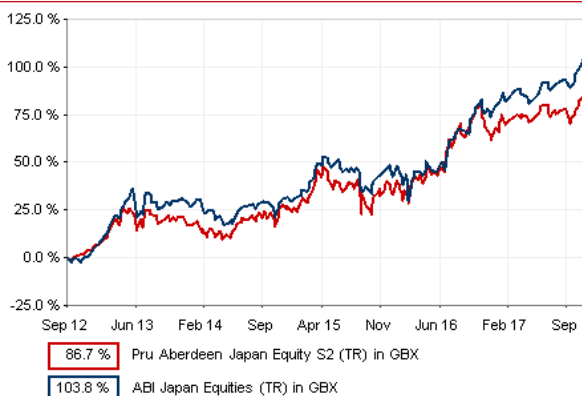

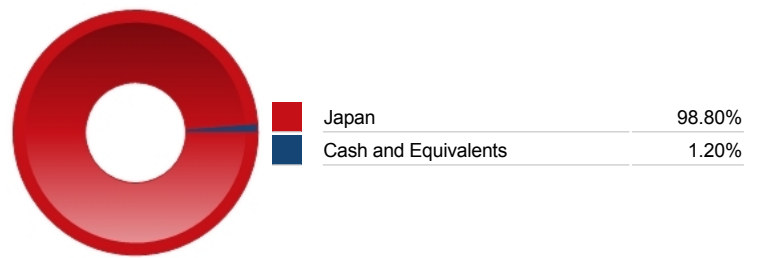

Regional Allocation



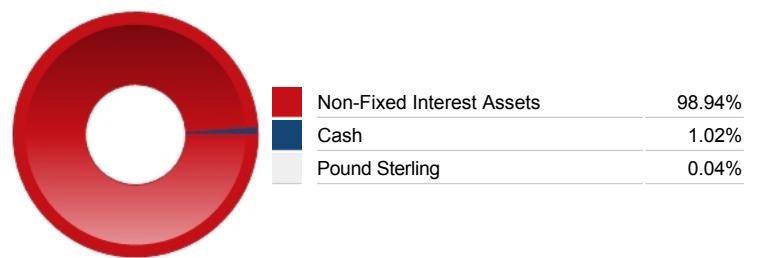
