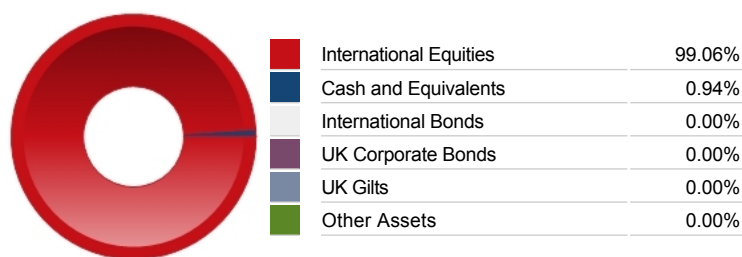

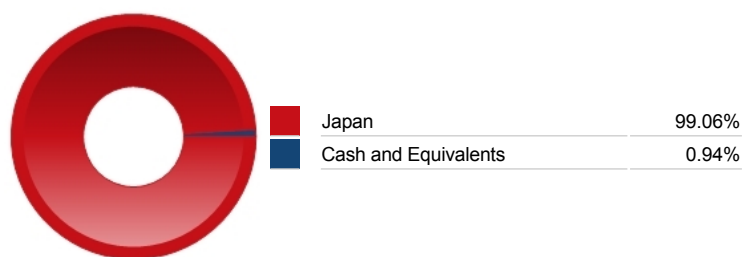

Regional Allocation



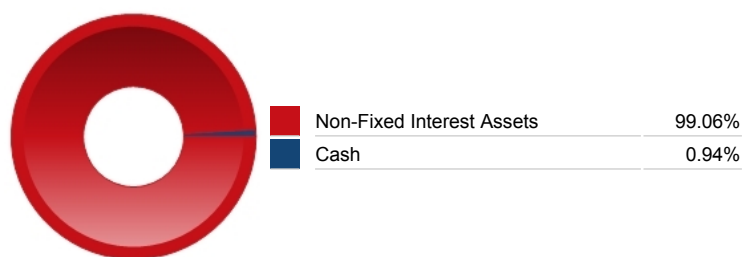
