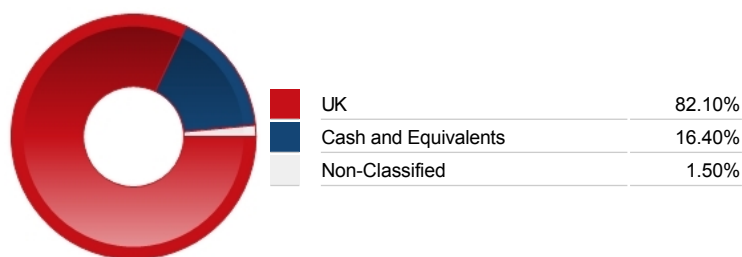

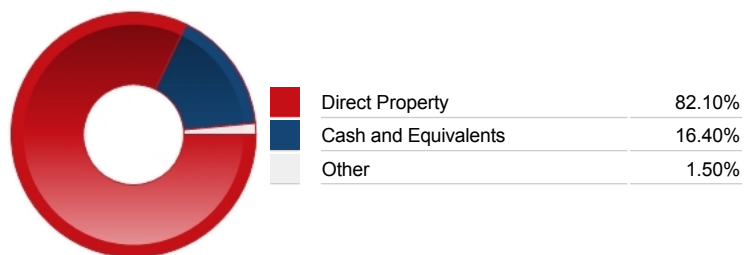
Asset Allocation



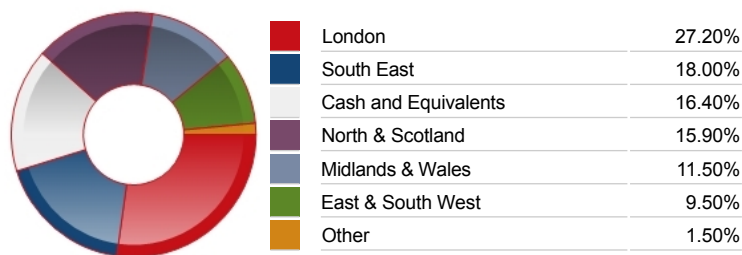
Regional Allocation
