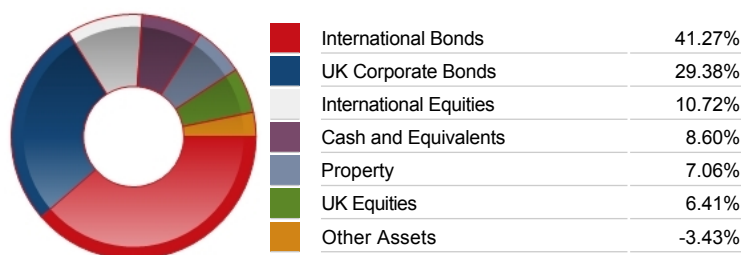

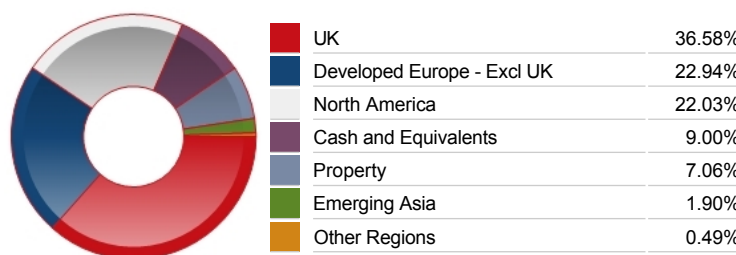

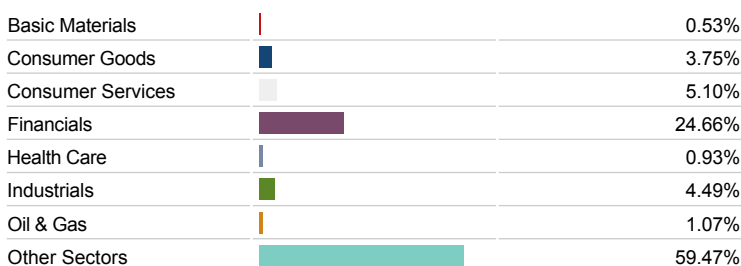

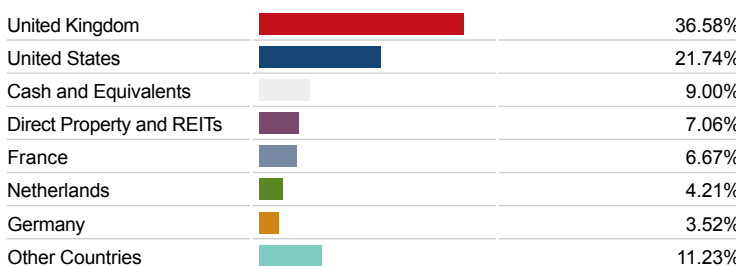
**Regional Allocation**



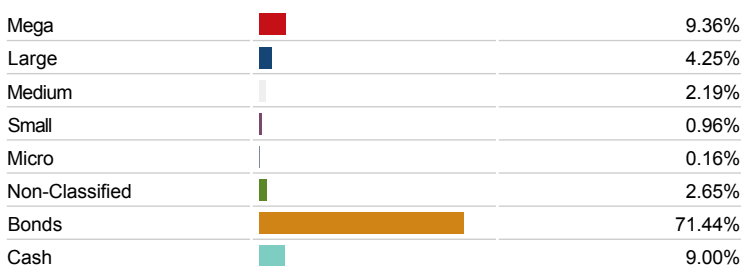

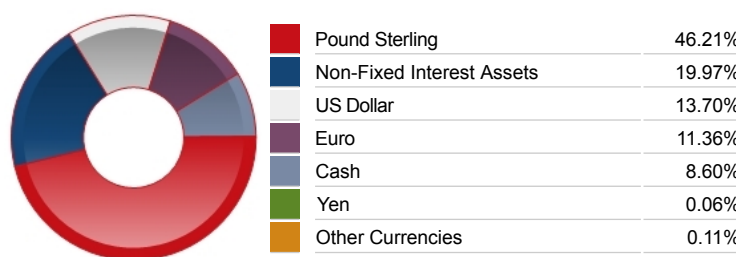

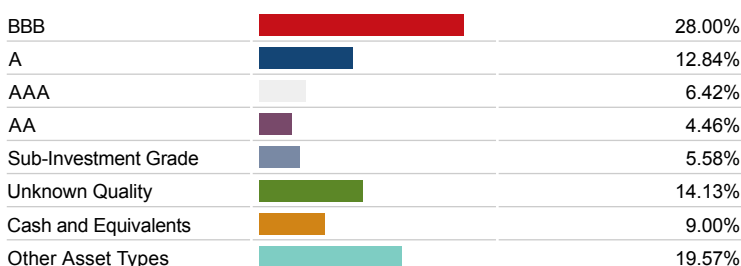
**Breakdown By Market Cap (%)**



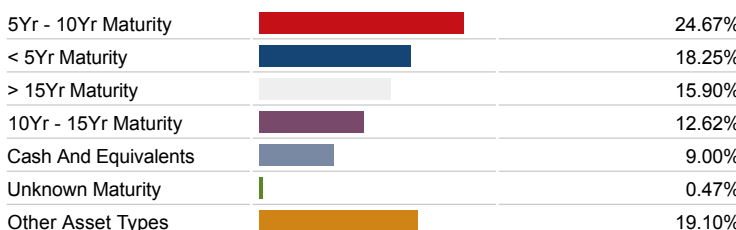
