Objective: The investment strategy of the fund is to purchase shares in UK companies via other M&G funds. The underlying funds may also invest in other transferable securities, cash, and near cash, directly or via funds (including funds managed by M&G) and may use derivatives for efficient portfolio management and hedging.

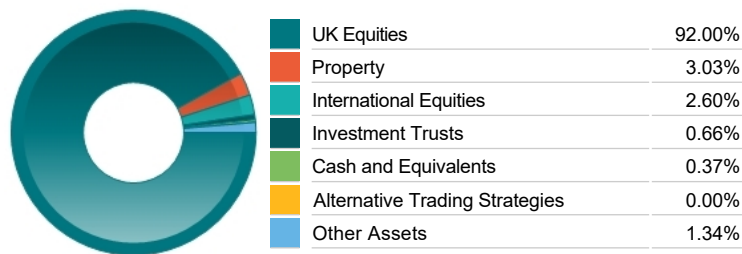

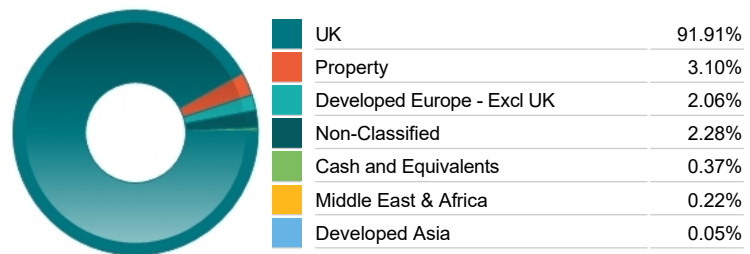

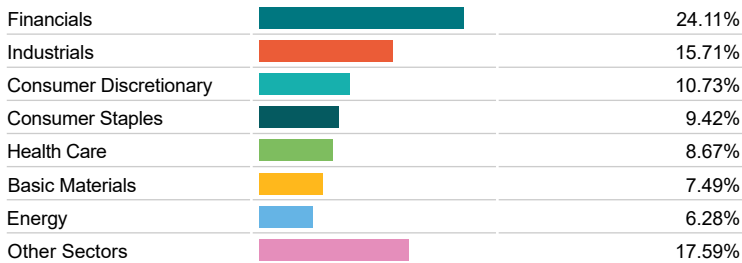
Asset Allocation



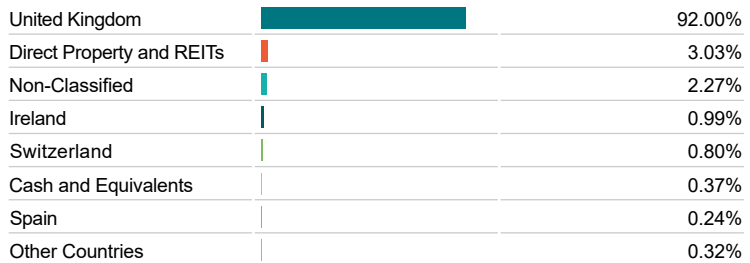
Regional Allocation



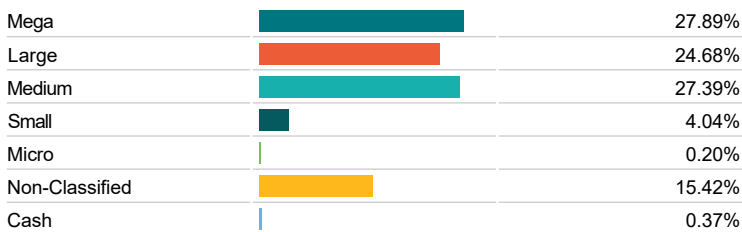
Sector Breakdown



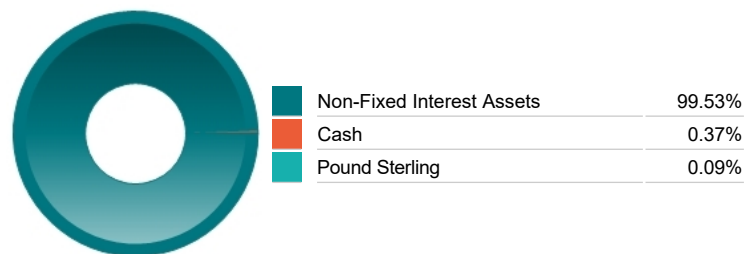
Top Country Breakdown
