Market commentary

European equity markets have been impacted in July by continued geo-political uncertainties and mixed corporate earnings results. Most continental European stock indices retreated, led by Portugal where Banco Espirito Santo (BES)'s share price collapsed - suffering heavy losses from exposure to its parent company which missed payments on debt obligations - triggering a bailout rescue package. Among industry segments, only technology and healthcare gained ground in July, while all the remaining sectors regressed. The oil & gas sector witnessed the biggest drop in price values, amid a new set of economic sanctions against Russia, announced by European and American leaders. But despite prevailing challenges, the macro-environment in Europe is still showing a slow but steady positive momentum, especially in some 'periphery' markets. Latest jobless data showed figures decreasing (albeit modestly) and beating estimates, with very strong employment numbers from Spain. While France and Germany lagged, Purchasing Managers' Index outputs for the rest of Europe recorded the largest monthly increase in business activity since August 2007. Notwithstanding the still low level of inflation, we believe the combination of these factors should set the stage for improving growth in Europe.

Fund strategy

Our strategy rests primarily on rigorous fundamental analysis and company valuations, combined with a close scrutiny of the macroeconomic context, to identify what we believe to be the best investment opportunities in Continental Europe. Portfolio holdings remained broadly stable in July, with no new positions initiated, as equity markets absorbed the political and economic news-flow from Russia and Portugal. While we do not hold any financial company in Portugal, we continue to be overweight financials relative to the benchmark, as we believe this sector offers attractive long-term valuations in Europe. We see recent events at BES as more the result of lax corporate governance in one institution than anything systemic. We continue to be underweight the consumer goods sector, which in our view contains expensive perceived 'safe haven' stocks, which could become less desirable as economic and financial conditions improve.

Investment objective

The Invesco Perpetual European Equity Fund aims to achieve capital growth in Continental Europe. The fund intends to invest primarily in shares in companies in Continental Europe, although it may include other European related investments. In pursuing this objective, the fund managers may include investments that they consider appropriate which include transferable securities, money market instruments, warrants, collective investment schemes, deposits and other permitted investments and transactions as detailed in Appendix 2 of the most recent Prospectus.


