Benchmark

Benchmark: Investment Association Sterling Corporate Bond Sector*

This is a Comparator Benchmark. Given its asset allocation the Fund's performance can be compared against the Benchmark. However, the Fund is actively managed and is not constrained by any benchmark.

* Many funds sold in the UK are grouped into sectors by the Investment Association (the trade body that represents UK investment managers), to facilitate comparison between funds with broadly similar characteristics.

Fund investment objective and policy

The objective of the Fund is to achieve income and capital growth over the medium to longterm (3 to 5 years plus). The Fund invests at least 80% of its assets in investment grade corporate debt securities. The Fund may use derivatives (complex instruments) for investment purposes and to manage the Fund more efficiently, with the aim of reducing risk, reducing costs and/or generating additional capital or income.

Fund strategy

The fund retains a relatively low level of interest rate risk and high level of liquidity. Within the bond element the highest allocation is to subordinated financials (both banks and insurers). We also hold some exposure to US dollar denominated corporates. Smaller allocations are currently held in corporate hybrids.

Investment risks

This has the effect of reducing the estimated distribution and underlying yields and the actual distribution rate.
