Investment Proposition

Performance is driven by stock selection. Ideas are sourced across both investment grade and high yield and are driven by our fundamental, bottom-up stock analysis. The portfolio is well diversified with exposure typically to between at least 40-60 companies. The portfolio could be characterised as comprising the "best ideas" we can find across the high yield and investment grade markets.

BAILLIE GIFFORD

We monitor our performance with reference to an index which comprises 70% investment grade and 30% high yield bonds.

Foreign currency bond holdings are typically hedged back to sterling. The Fund uses derivatives principally to reduce unwanted risks such as foreign currency exposure. This can involve the use of currency forwards, bond futures and interest rate swaps.


