The portfolio is made up primarily of a diversified and actively managed range of UK and international equity funds.

The large majority of the Fund is invested in collective investment schemes thereby greatly reducing stock specific risk.

A small portion of the Fund may be held in alternative assets where the manager believes these can produce equity like returns but with a low correlation to global stock markets.
