Market commentary

Year to date the FTSE All Share index remains broadly unchanged, falling by 0.3% in July. Whilst instability across Middle East is attracting ever more international attention, UK stock market volatility has remained low, arguably reflecting the lack of attractively valued alternative asset classes, and pitifully low deposit rates. Among the key contributors to performance were Capita, Drax Group and Allied Minds. In its half year results, Capita announced a 10% increase in interim dividend and some contract wins. Drax's share price, having been hurt by the removal of a government subsidy earlier in the year, bounced on news that the government has been instructed to reconsider its decision. The share price of Glaxo fell on the back of downbeat half year results, which revealed increased competition in the US respiratory market. Nonetheless the company announced a 6% increase in quarterly dividend and at the time of writing the shares are trading on a net dividend yield of over 5% (Source: Bloomberg).

Fund strategy

Although equity valuations have moved higher over the last year, within the UK company universe there has been a wide divergence of performance both at the company level and at the share price level, such that the fund manager continues to identify pockets of value. Moreover, he sees potential for Mergers and Acquisitions (M&A) activity to accelerate. Year-to-date such activity has been prevalent in the tobacco and healthcare sectors, both sectors which are well represented in the fund's portfolio. With or without the benefit of further M&A activity, long term returns will ultimately be driven by the ability of underlying portfolio companies to grow their earnings and dividends in what remains a competitive landscape. It is precisely such companies, with resilient earnings growth potential, that the fund manager continues to target.

Investment objective

The Invesco Perpetual UK Strategic Income Fund aims to produce an above average income with capital growth primarily through a portfolio of investments in UK companies. In pursuing this objective, the fund managers may include other investments that they consider appropriate which include transferable securities, money market instruments, warrants, collective investment schemes, deposits and other permitted investments and transactions as detailed in Appendix 2 of the most recent Prospectus.
