

# **CF Canlife Global Equity Fund**




# **Fund objective**

The fund aims to provide capital growth mainly from investment in shares globally.

#### **Fund characteristics**

The fund invests in five different geographical areas – Asia Pacific, Europe, Japan, North America and the UK and seeks to add value through both asset allocation and stock selection. The fund's asset allocation strategy is reviewed quarterly with input from each of the fund managers within the International Equity team. Stock selection is a collaboration between the fund manager and the regional specialists resulting in the highest conviction ideas from across the globe.




