

# Emerging Markets Leading Companies Fund

## Fund Aims

To maximise the total return through investment primarily in a concentrated portfolio of the larger and more tradeable companies, as measured by the value of their freely floating shares and value of shares traded, in emerging markets worldwide and in any economic sectors of such markets. The Fund's share price can be volatile due to movements in the prices of the underlying holdings and the basis on which the Fund is priced.

## Investment Proposition

The Fund aims to invest in an actively managed portfolio of emerging market stocks, focusing on larger and more liquid names.

We invest on a long-term (5 year) perspective, and have a strong preference for growth. We are looking for significant upside in each stock that we invest in.

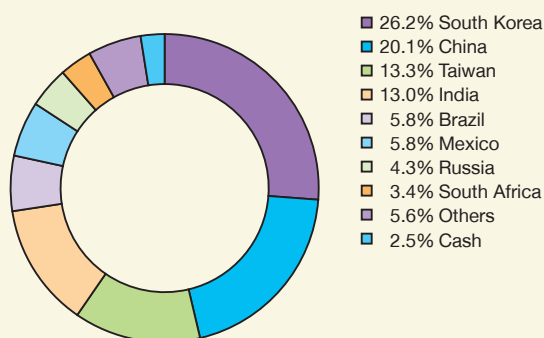
The process is driven by rigorous, fundamental, bottom-up analysis undertaken by our dedicated emerging markets team.

The fund manager draws on this analysis, as well as insights gleaned from discussion with all of Baillie Gifford's global investors, to produce a portfolio that typically holds 40–80 stocks.

## Geographic Analysis of Total Assets



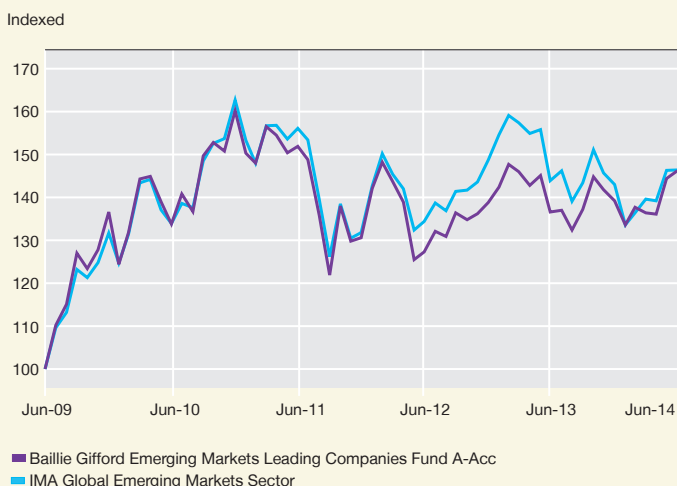

The Fund is a sub-fund of the Baillie Gifford Overseas Growth Funds ICVC (Investment Company with Variable Capital) which is an umbrella Open-Ended Investment Company. Its Authorised Corporate Director ('ACD') is Baillie Gifford & Co Limited.

The share price is calculated daily at 10.00am and is based on the mid value of the underlying assets of the Fund, known as the net asset value. All shares are single priced.
