
JPMorgan Chinese Investment Trust plc

Monthly Update as at 31 May 2015

Management Commentary

The trust's net asset value outperformed the benchmark, while the share price underperformed. Stock selection in China contributed to the vast majority of positive performance. The main contributors were mainland-listed holdings such as Hangzhou Hikvision Digital, Zhengzhou Yutong Bus and Spring Airlines, which rallied in line with strength in A-shares and on stronger-than-expected fundamentals. Stock selection was also strong, particularly Chinese stocks listed in Hong Kong, with names such as China Mengniu Dairy and China Conch Venture witnessing an improvement in fundamentals in their niche growth end markets. In Taiwan, iPhone-related names such as Largan Precision continued to outperform. Overweights in Taiwanese financials such as Fubon Financial and Chailease Holding detracted, as they corrected after a strong April. We were also impacted by our holding in China Resources Gas Group, which fell on a deceleration in gas demand.

The Company has the ability to use borrowing to gear the portfolio within the range of 10% net cash to 15% geared in normal market conditions.



GLOSSARY OF TERMS

BENCHMARK COMPARISON - Comparison of the Company's performance is made with the benchmark. The benchmark is a recognised index of stocks which should not be taken as wholly representative of the Company's investment universe. The Company's investment strategy does not follow or track this index and therefore there may be a degree of divergence between its performance and that of the Company.

CASH - Net current assets including investment in liquidity funds & treasury stocks (if held) and drawn revolving credit facilities (if any) with an original maturity of less than 1 year.

DISCOUNT / PREMIUM - If the share price of an investment company is lower than the net asset value (NAV) per share, the company is said to be trading at a discount. If the share price of an investment company is higher than the net asset value (NAV) per share, the company is said to be trading at a premium. The discount/premium is shown as a percentage of the NAV.

GEARING - Gearing represents the excess amount above shareholders' funds of total assets expressed as a percentage of the shareholders' funds. Total assets include total investments and net current assets/liabilities less cash/cash equivalents and excluding bank loans of less than one year. If the amount calculated is negative this is known as a 'net cash' position.

SECTOR / GEOGRAPHICAL BREAKDOWNS - These are expressed as a percentage of total portfolio and cash. Investments in liquidity funds will be shown as cash.
