## Authorised Corporate Director's Annual Short Report for the year ended 30th September 2013

### Investment Objective

The Fund aims to maximise total return, through combined capital growth and income payment whilst achieving a higher level of income than that earned from investment only in comparable UK government bonds.

### Investment Policy

To invest worldwide mainly in investment grade bonds issued in sterling. Derivatives, which are a type of financial contract, may be used to protect or increase the value of the shares.

### Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.

The Fund is classified in the category above because it invests in corporate bonds which generally provide higher rewards and higher risks than other investments such as government bonds and cash. The indicator does not take into account the following material risks of investing in this Fund: Investment markets can go down as well as up and market conditions can change rapidly. The value of an investment in the Fund, and any income from it, can fall as well as rise and you may not get back the amount invested. ### Investment Report

For the year to 30th September 2013 the gross return on B Net Income Shares was 3.9%<sup>2</sup> (net return 2.9%<sup>3</sup>) compared to the return on the Bank of America Merrill Lynch Sterling Non-Gilts Over 10 Year Index of 1.8%<sup>4</sup>. We believe that shorter-term performance measurements are of limited relevance in assessing investment ability and would suggest that three years is a more sensible time frame over which to judge performance. The Fund's performance over one year, three years and five years has been ahead of its comparative index.

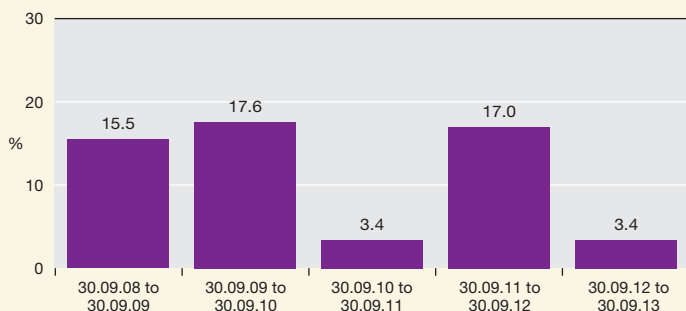
Returns on many bond investments in the year under review have been rather pedestrian when compared with the high returns of recent years. Government bonds, as measured by the Bank of America Merrill Lynch's UK Gilt Over 10 Year Index, delivered a negative return as rising yields pushed prices down faster than income was earned. That investment grade bonds managed a small positive return resulted in part from a higher starting yield. Whilst the 'risk free' component of corporate bond yields rose, the credit risk premium relative to government bonds fell notably which limited the overall rise in corporate bond yields and correspondingly their price fall.

The last year has seen a steady fall in the credit risk premium as fears of catastrophe in the Eurozone have subsided and investors have focussed instead on the good health of most companies' balance sheets and their currently prudent financial strategies. Improved risk appetite has particularly benefitted some of our longstanding holdings in the insurance sector. Moreover one such, Phoenix Life, took a big stride in its rehabilitation by raising equity and extending the maturity profile of its bank debt which led to a sharp rally in the company's bonds.

Building on Baillie Gifford's heritage of global investment we have ventured further afield in our search for attractive investment opportunities this year. In particular, following company meetings in our offices and in Sao Paulo, we have taken small holdings in the bonds of two blue-chip Brazilian industrial conglomerates, Odebrecht and Votorantim Cimentos. These companies are clear market leaders domestically and also have strong positions internationally, in the case of Odebrecht, or as exporters in the case of Votorantim Cimentos.

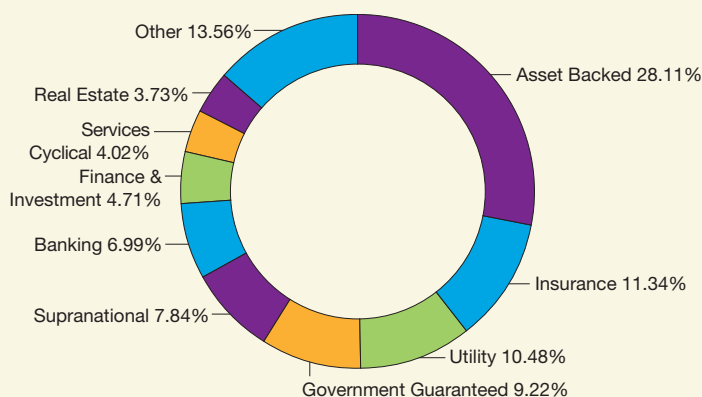

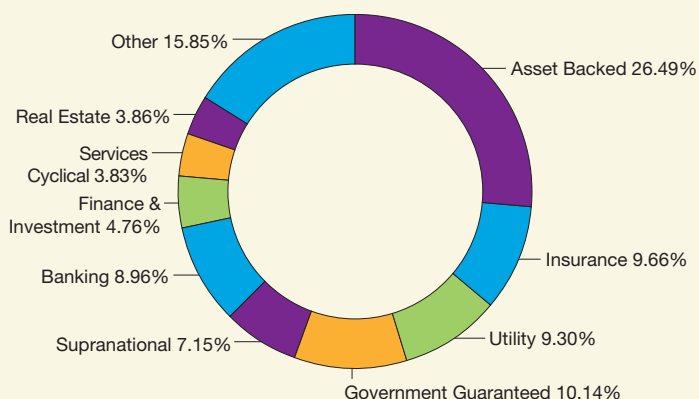

## Dilution Adjustment

The level of the dilution adjustment is set by the ACD based on prevailing market conditions. Given the volatility and illiquidity in corporate bond markets the ACD has a threshold for daily net inflows or outflows of cash into or out of the Fund. Above this threshold, which varies according to market conditions, the ACD will increase the dilution adjustment to reflect the increased dealing costs incurred by the Fund as a result of larger inflows and outflows. A consequence of this policy is, however, that smaller transactions made on any day that the relevant threshold is exceeded will also trade at the price incorporating the higher adjustment and this may lead to increased dealing costs. Further information regarding the dilution adjustment may be found in the Supplementary Information Document or the Prospectus.

## Minimum Investment Levels

The minimum initial investment is £250,000 for Class B Shares. Class C Shares are only available to persons to whom an associate of the ACD provides services under an investment management agreement. Class C Gross Accumulation Shares are only available to shareholders who demonstrate to the ACD's satisfaction that they fall within one of the specified categories referred to in Sections 933–977 of the Income Tax Act 2007. Details of the minimum holding and redemption levels can be found in the Supplementary Information Document and Prospectus.
