Investment objective and policy

The objective is to generate long term capital growth. Investment will be mainly in shares or units of collective investment schemes investing (directly or indirectly) in equities or fixed interest securities or pursuing an absolute return objective in any geographical area or sector. The Portfolio may include an indirect exposure to property with any geographic or sector focus. The Portfolio may also invest in other collective investment schemes (including unregulated schemes) and directly in transferable securities, money market instruments, near cash, cash and deposits. Manager's review

Global equities rose during the period under review. The outgoing chairman of the US Federal Reserve (Fed), Bernanke announced the beginning of tapering against improving economic data. European equities continued to recover, especially domestically-focused businesses as sentiment improved, driven by positive economic growth and lower borrowing costs in the periphery. However, in 2014 market volatility returned, driven in January by slower Chinese growth data, and towards the end of the period, the Russian annexation of Crimea.

Portfolio review

Over the six-month period under review, the strongest contribution to returns came from fixed-income strategies. The absolute-return-oriented fixed-income positions of Threadneedle Global Opportunities Bond and Ignis Absolute Return Government Bond both delivered solid returns, while JP Morgan Income Opportunities posted a modest gain. The only fixed-income position which detracted was Liontrust Global Strategic Bond, which suffered from exposure to emerging-market bonds and currencies which underperformed developed markets. Returns from long-short managers were broadly positive with Henderson UK Absolute Return, Majedie Tortoise and Melchior European Absolute Return all contributing. However, long-biased holdings had a tough time with Coupland Cardiff Asia Alpha and Coupland Cardiff Japan Alpha both posting large negative returns. It was also a challenging time for the macro-oriented managers with Odey Swan and CF Eclectica Absolute Macro suffering due to significant market rotation during the first quarter of 2014. During the period, very few changes were made to the portfolio. However, holdings in BlackRock Absolute Return Bond and BH Global were sold for positions where we see better prospects.

Outlook

Interestingly, global markets trended higher despite emerging market growth concerns and Ukrainian geopolitical tensions. Focus has now shifted from the headwind of US Fed tapering, to when base rates will rise. However, rate hikes are dependent upon improved economic conditions. For the markets to keep rising, we need to see evidence of stronger growth translating into better profits for businesses. In our recent meetings with underlying fund managers, we were not surprised by lower market expectations, although they were confident that corporate earnings would rise. Hence, although we believe the gradual shift away from loose monetary policy will cause periodic spikes in volatility, we see this as a transition phase in the context of more robust long-run returns.

The Committee of European Securities Regulators (now named the European Securities and Markets Authority), introduced new methodology in 2012 for the calculation of ongoing charges figures which replaced total expense ratios. It is the ratio of the total ongoing charges to the average net asset value over twelve months and includes the annual management charge, the other operating expenses and a synthetic element of 0.93% (2013, 0.98%) to incorporate the ongoing charges of underlying fund investments.
