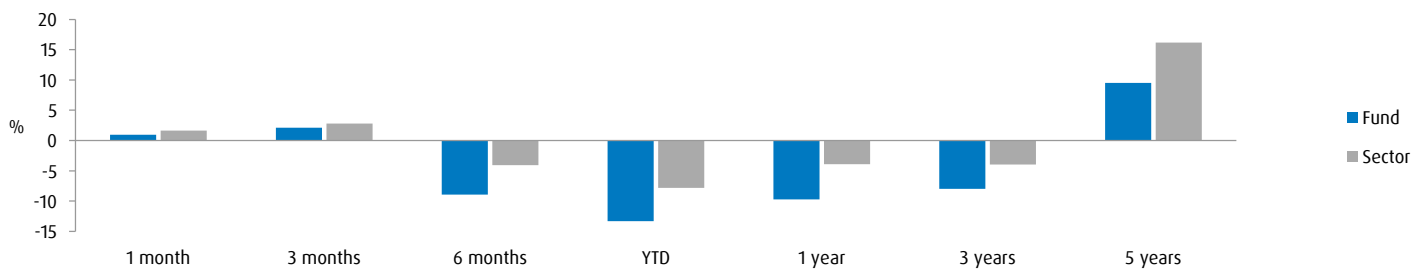
The Fund aims to achieve an income return, with some capital growth.
