The Fund invests in UK smaller companies using the Economic Advantage process. Anthony Cross and Julian Fosh use the process to identify companies with a durable competitive advantage that allows the companies to defy industry competition and sustain a higher than average level of profitability for longer than expected. All smaller companies in the Fund must have a minimum 3% directors' equity ownership, which we believe motivates key employees, helps to secure a company's competitive edge and leads to better corporate performance. 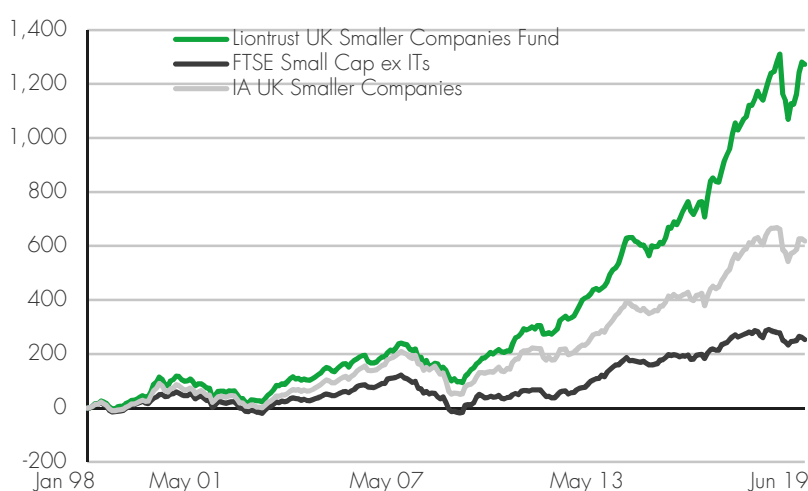
