Jeremy joined AXA Investment Managers in July 2007 and is the lead fund manager of the AXA Framlington Global Technology Fund. In 2017 he was named winner of the Tech Fund Manager of the Year Award at the UK Tech Awards. Previously he was named winner of the Investment Week Tech & Telecoms Fund Manager of the Year Award for 2011 and 2012.

Previously, he was a senior portfolio manager at Close Investments (formerly Reabourne Technology), a subsidiary of Close Brothers Group PLC, from 2003 to 2007, having been a portfolio manager for the previous three years and an assistant portfolio manager from 1997 to 2000 with Reabourne Technology. During his time at Close Investments / Reabourne, Jeremy was the lead fund manager on several technology funds and won the FTSE techMARK Technology Fund Manager of the Year award in 2003 and 2005.

Jeremy holds a BSc (Hons) in Mathematics (1st class) and an MSc. in Systems Engineering from Cardiff University (1992-1996). He is also a CFA charterholder.

Objective

The aim of this Fund is to provide long-term capital growth.

Fund manager's commentary

Main changes to the portfolio during September

We initiated new positions in cybersecurity firms ZScaler, SailPoint, and Rapid7. We also started a position in Cree, the maker of silicon carbide materials, used in a variety of automotive semiconductor devices.

We sold our holding in Carbon Black, the provider of endpoint security solutions, after the firm accepted a bid from VMWare. We also sold our holding in ride-sharing company Uber.

Factors affecting performance during September

Global equity markets rose in September, with the MSCI World Index climbing 1%, while the technology sector underperformed, with the MSCI World Information Technology Index gaining 0.6%.

There was a noticeable rotation within the month, with stocks trading on higher valuations being sold off whilst more value-centric names performing better. Some of our software investments such as Hubspot are in the former group, while our semiconductor investments, such as Samsung and Ambarella, were among our top performers.

Current market influences and outlook

Global macro concerns continue to overhang the market and the recent decision by the US Federal Reserve to again reduce interest rates has left equity investors nervous about the overall health of the global economy.

As a result, we are experiencing a period where risky assets are being sold, somewhat indiscriminately. With several long-term themes driving growth in the technology sector, we would be inclined to add to our investments as markets stabilise.


