Objective

Aim: The fund will seek to outperform its benchmark, the LIBID GBP 7 Day Index, over rolling 12 month periods. Capital invested in the fund is at risk and there is no guarantee that this target will be achieved over the 12 month rolling periods, or any other time period.

Investment process: The fund invests predominantly in cash as well as investment grade debt securities issued by governments, government agencies and supra-nationals. It can invest across a range of securities including cash, deposits, floating rate notes, money market instruments, short dated debt securities and other debt securities. The fund has a higher exposure to counterparty risk. Market counterparties could become unable to make interest payments or repay debt. As such the value of the fund will fall in the event of a counterparty default.

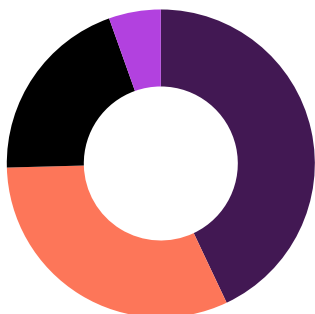
