Investment process:

The fund will seek to outperform its benchmark, the LIBID GBP 7 Day Index, over rolling 12 month periods. Capital invested in the fund is at risk and there is no guarantee that this target will be achieved over the 12 month rolling periods, or any other time period.

The fund invests predominantly in cash as well as investment grade debt securities issued by governments, government agencies and supra-nationals. 
