## Investment Objective and Investment Policy

<p><b>Objective:</b></p> <p>The investment objective of the Fund is to provide long-term capital growth, i.e., over a period of at least 5 years.</p> <p><b>Policy:</b></p> <p>The Fund will seek to achieve its objective from an actively managed and diversified portfolio of collective investment schemes, including investment trusts.</p> <p>The Fund will have exposure to cash, fixed interest securities, equity, and equity-linked investments selected from various markets worldwide, encompassing a variety of economic sectors.</p> <p>The Fund will typically invest between 20% and 60% of its portfolio in schemes which invest in equity securities.</p> <p>The use of derivatives is not permitted, but borrowing of up to 10% of the Fund's net asset value will be permitted on a temporary basis. The Fund may invest in hedged share classes of underlying funds.</p> <p>The Fund may hold up to 10% of its net asset value in cash or near cash where this is considered reasonable in achieving the objective of the Fund.</p> <p>Borrowing of up to 10% of the Fund's net asset value will be permitted on a temporary basis. 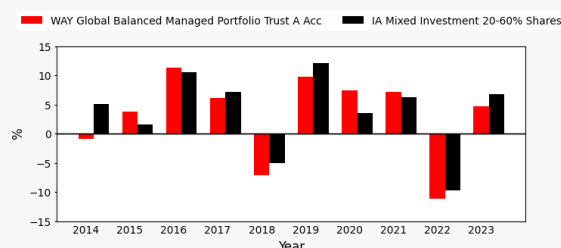
