Objectives and Investment Policy

The Fund aims to provide a positive capital return over a 12 month period, regardless of market conditions, with a lower level of volatility returns than the UK equity markets on average. Capital is at risk and there is no guarantee that a positive return will be achieved over a 12 month, or any, period.

The Fund aims to meet its objective by principally investing in a portfolio of UK equities. The Fund may also invest in transferable securities, money market instruments, deposits, cash and near cash.

The Fund has the discretion to invest in a range of investments as described above.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) may be used to manage the Fund more efficiently. The Fund may also hedge part or all of the equity market risk arising from its underlying investments in order to attempt to reduce the risk of potential capital losses.

The Fund has no particular industry or economic sector focus.

You can buy and sell shares in the fund on any business day.

Any income from the Fund will be reinvested to grow the value of your investment.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 4 because weekly historical performance data indicates that it has experienced average rises and falls in market prices historically.

The following risks are material in addition to the risks captured by the indicator above:

- **Counterparty risk:** The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- **Market Risk:** External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- **Currency Risk:** As the Fund invests in collective investment schemes which have exposure to overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- **Risk from use of derivatives:** Investment in derivatives may result in gains or losses that are greater than the original amount invested.

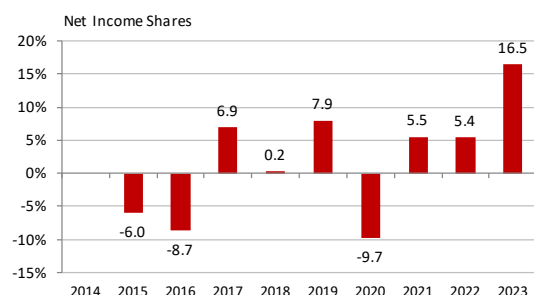
