### Objectives and investment policy

The aim of the Fund is to give you an income, paid to you four times a year, and grow the value of your original investment over the long term.

The Fund will invest globally, mainly in the shares of companies involved in the ownership and operation of infrastructure assets, including (but not limited to) electricity, water, gas, telecommunications, airports, roads, railways, seaports and social infrastructure assets (such as hospitals or prisons).

The Fund is actively managed which means that the Fund Manager will choose the investments, currencies and markets held in the Fund but always within the boundaries outlined in the Fund's objective and policy.

The full investment objective and policy, which outline all the eligible investments, are available in the Fund's prospectus.

You can buy, sell and switch shares in the Fund on any UK business day. We will need to receive your instruction before 12 noon to buy shares at that day's price.


#### Terms explained:

**Accumulation shares:** any income made by the Fund will be reinvested to grow the value of your investment.


Income shares: any income made by the Fund will be paid out to you.

#### Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.

The Fund is ranked as 5 because funds and portfolios holding similar assets have experienced medium to high rises and falls in value over the past five years.

Please note that even the lowest ranking does not mean a risk-free investment.

The Fund holds equities concentrated in global infrastructure sectors which can carry a higher risk than funds holding more diversified assets by sector. The assets held by the Fund are predominantly equities which have exposure to or are directly associated with infrastructure assets, revenues and profits and these may experience higher return volatility than bonds or money market instruments and can also be sensitive to changes in interest rates, inflation and emerging market risks. The Fund invests globally but may hold a concentration in one geographical location. Funds concentrated in one geographic location are more vulnerable to market sentiment in that specific location and can carry a higher risk than funds holding more geographically diversified assets.

The indicator may not take fully into account the following risks of investing in this Fund:

- Interest rate risk: infrastructure companies tend to hold relatively high levels of debt and their share price can be sensitive to an unexpected increase in interest rates.

- Legal or tax risk: arising from a change in legal regulations, tax rules or the application of them.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.


