The fund is actively managed and aims to limit the fluctuations ('volatility') the fund experiences to 14.5% per annum (before smoothing). In addition to generating financial returns most of the underlying funds apply at least one of the three ESG investing approaches: 1. Mitigating Environmental, Social and Governance risks and minimising negative outcomes 2. Pursuing Environmental, Social and Governance


