

Objective: The investment strategy of the fund is to purchase units in the BlackRock Gold & General Fund - the underlying Fund.

Underlying Fund Objective: The fund aims to provide a return on your investment (generated through an increase in the value of the assets held by the Fund) (gross of fees) over the long term (5 or more consecutive years beginning at the point of investment) through investment in shares of companies related to gold mining, commodities and precious-metals. 




Asset Allocation




Regional Allocation




Equity Sector Breakdown
