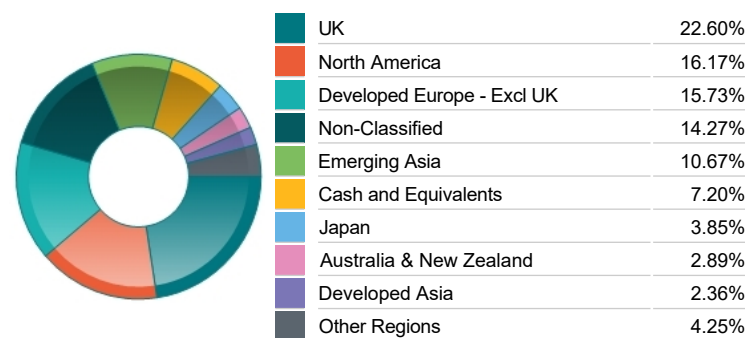

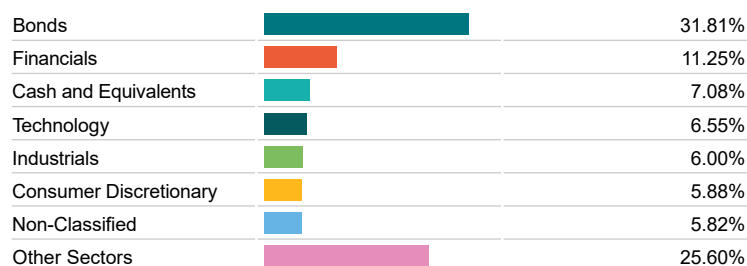

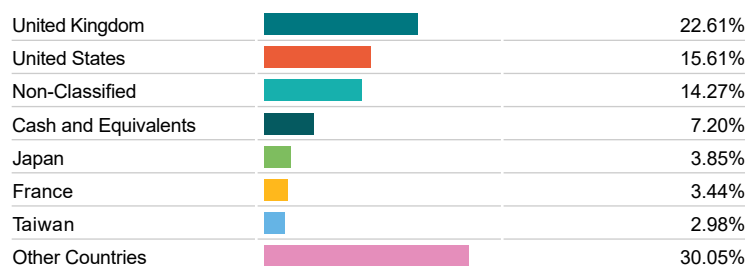
## Regional Allocation



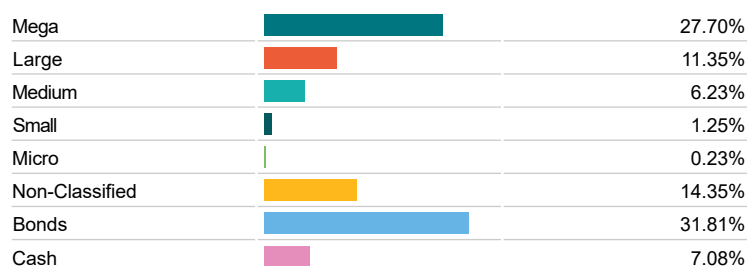

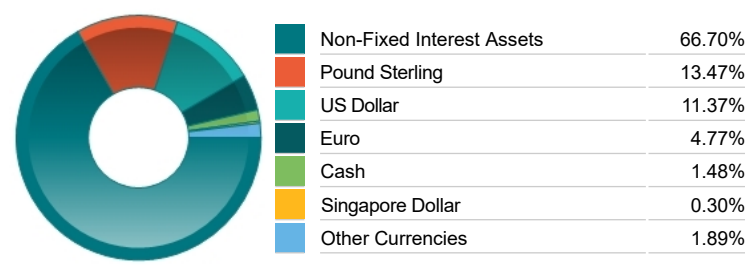

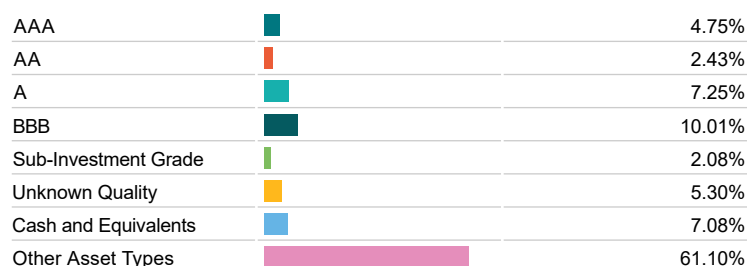
## Breakdown By Market Cap (%)



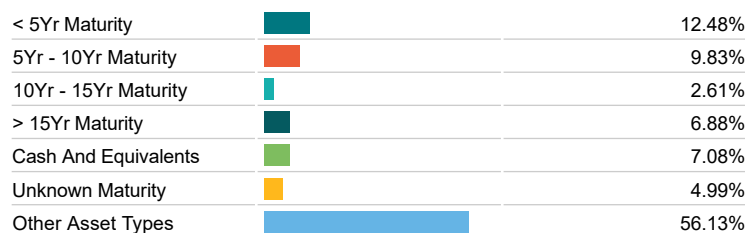
