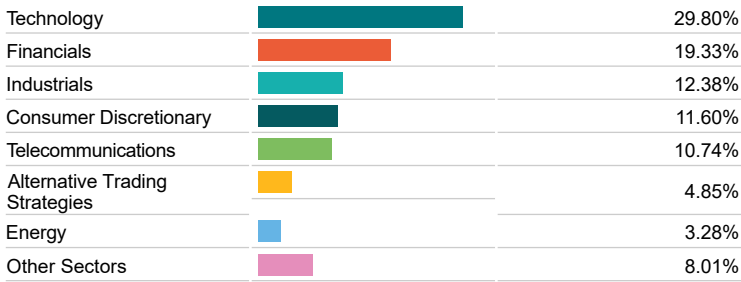

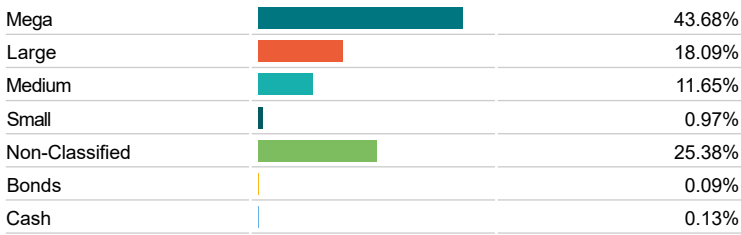
Asset Allocation



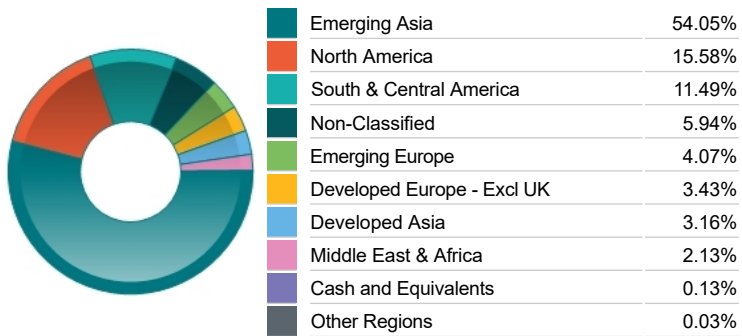
Equity Sector Breakdown



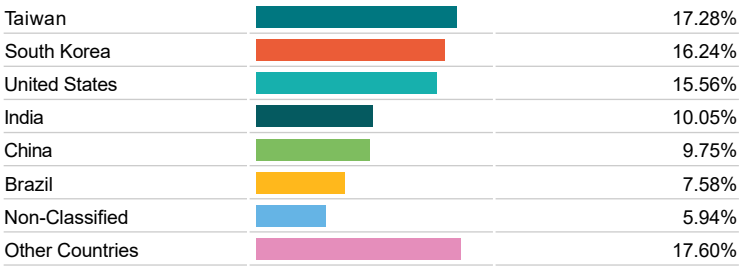
Breakdown By Market Cap (%)



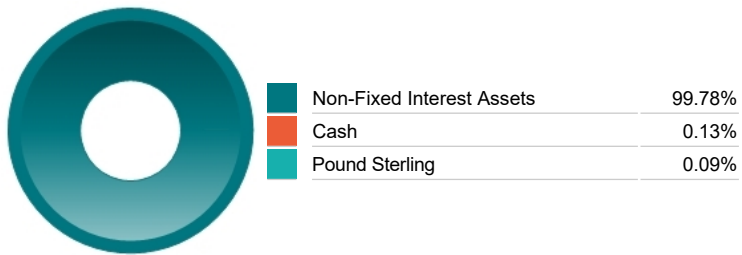
Regional Allocation
