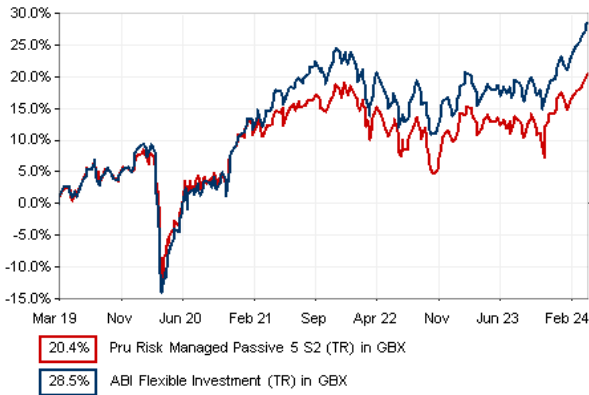

Aims

Objective: The investment strategy of the fund is to buy units in the WS Prudential Risk Managed Passive 5 Fund - the underlying fund.

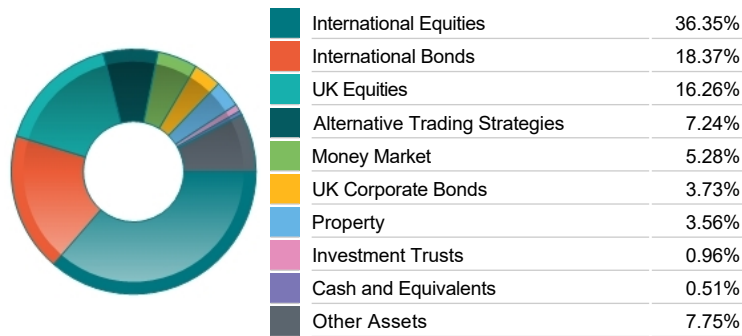

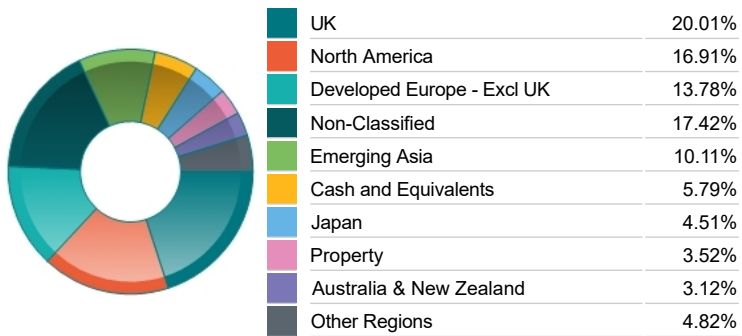

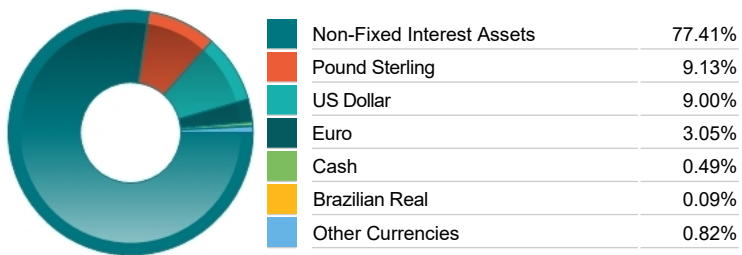
Regional Allocation
