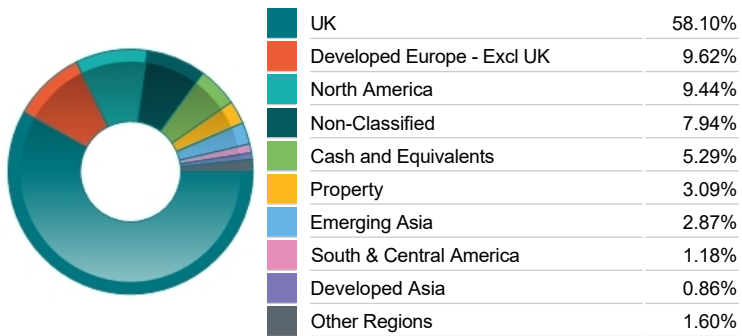

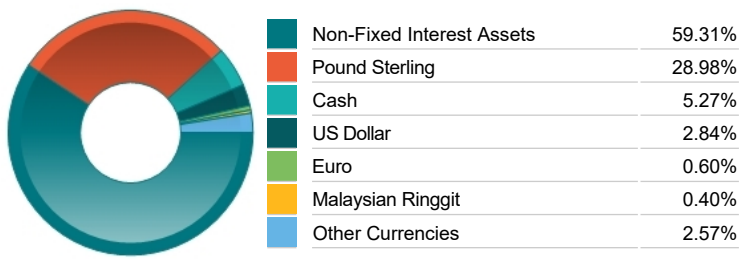
Regional Allocation
