At least 70% of the fund is invested directly in a diversified portfolio of commercial property in the UK. This may be reduced to 60%, if it is considered prudent for liquidity management. The fund may also invest in other property related assets such as: other types of property, including residential property; - property of any type outside the UK; - funds (including funds managed by M&G); and - transferable securities (such as shares and bonds); and money market instruments.
