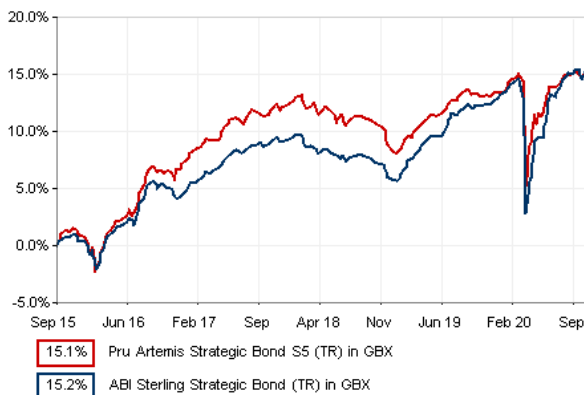

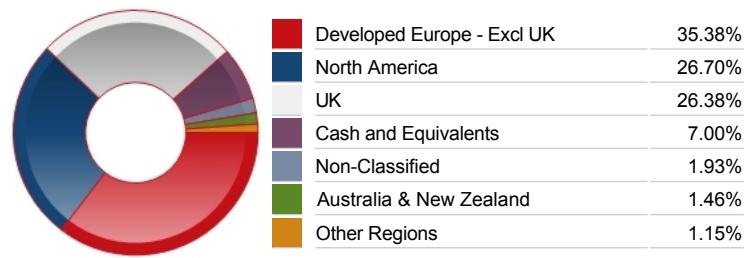

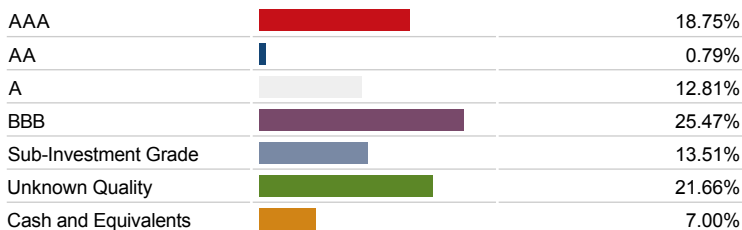
Bond Sector Breakdown



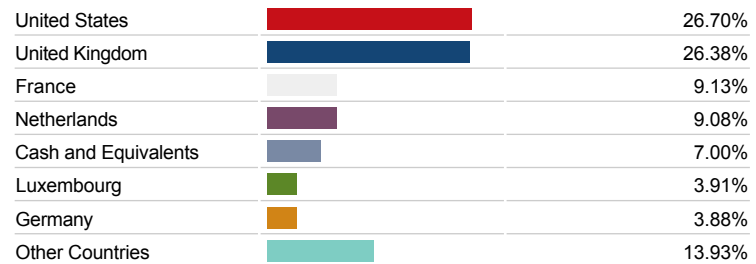
Breakdown By Market Cap (%)



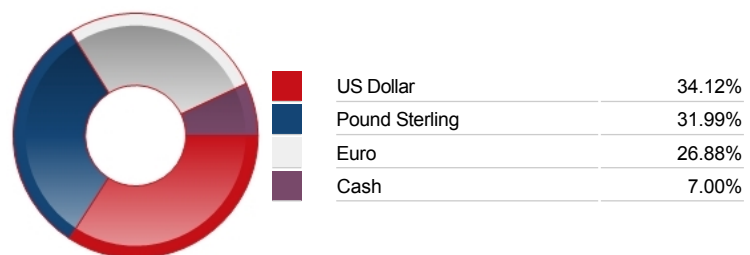
Fixed Interest Quality Profile



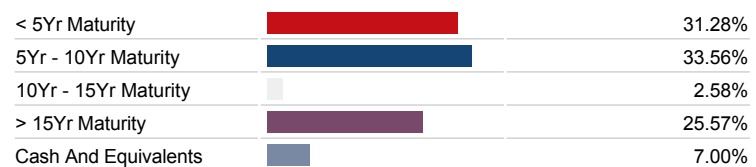
Top Country Breakdown
