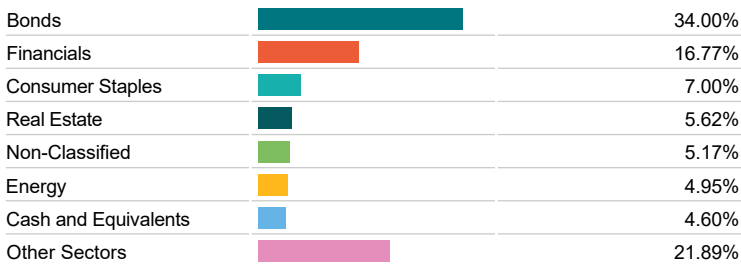

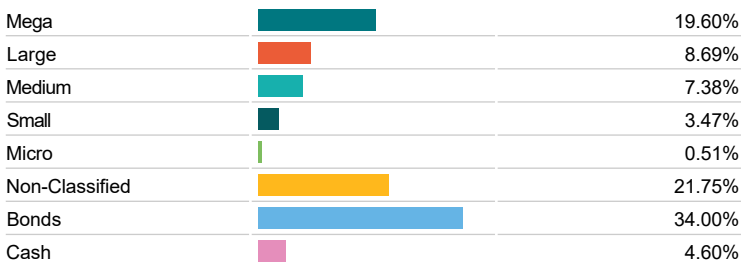
Asset Allocation



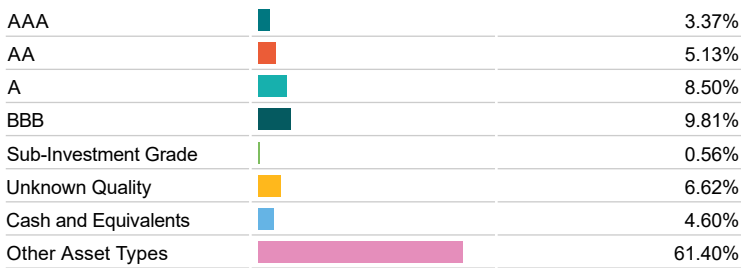
Sector Breakdown

Fixed Interest Quality Profile



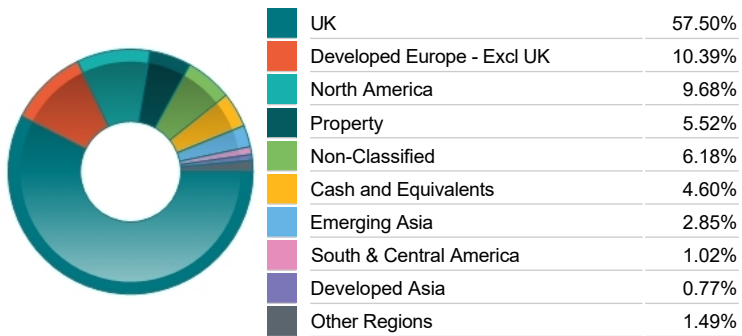

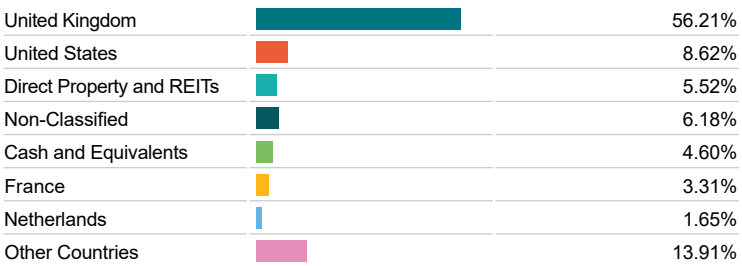

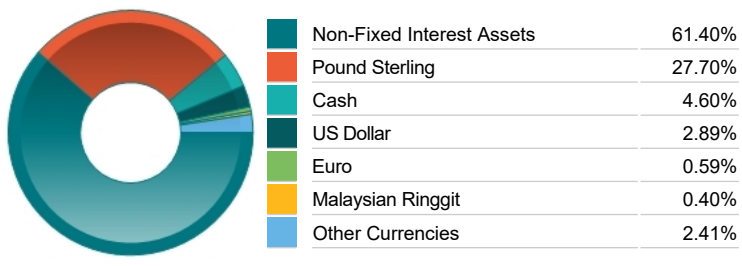
Regional Allocation
