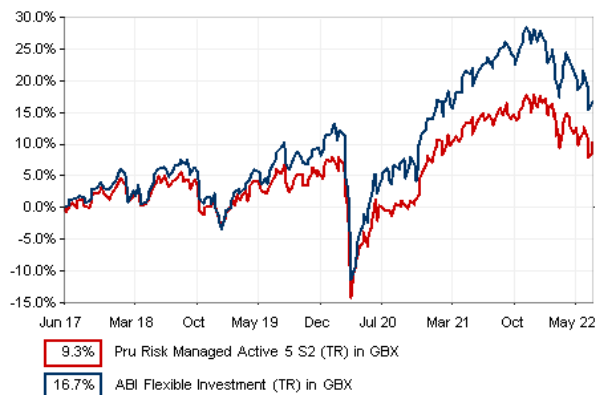

Objective: The investment strategy of the fund is to buy units in the LF Prudential Risk Managed Active 5 Fund - the underlying fund.

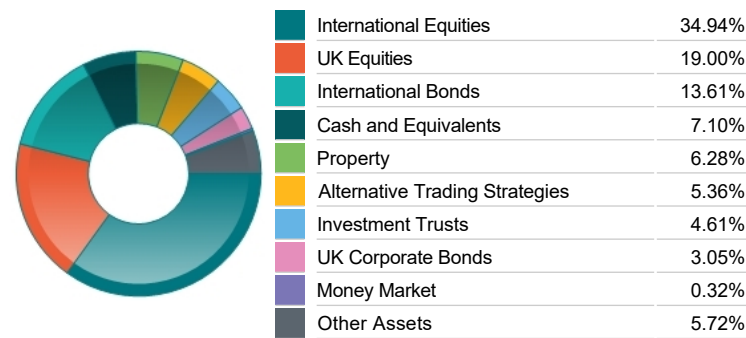

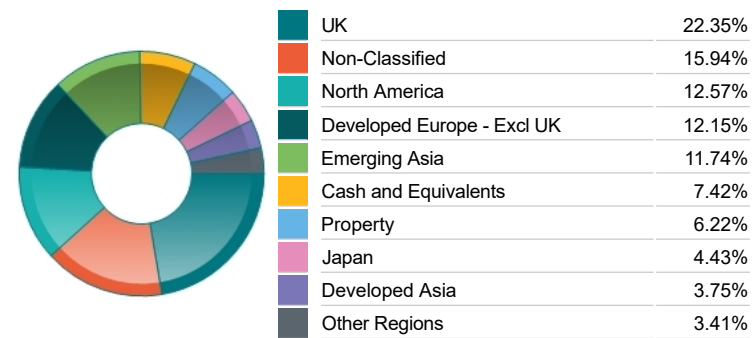

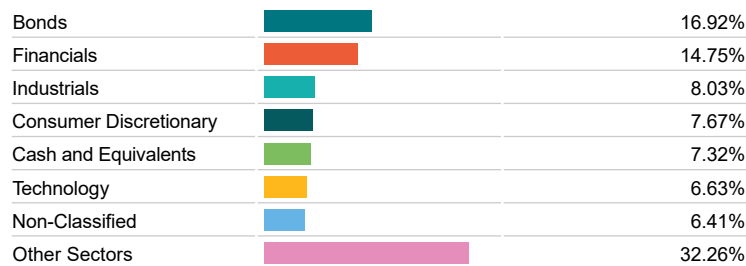

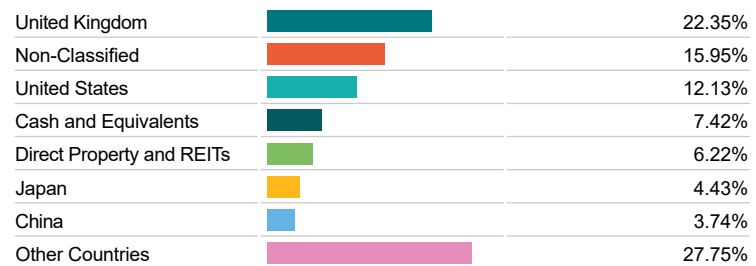
**Regional Allocation**



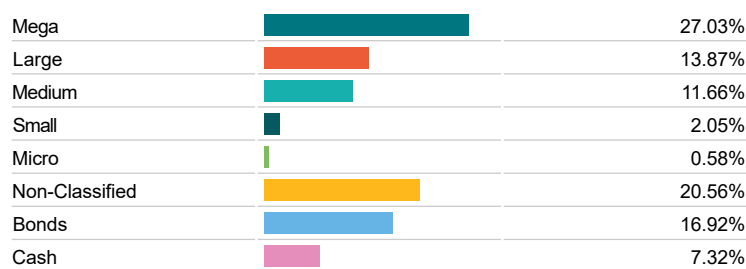
**Sector Breakdown**



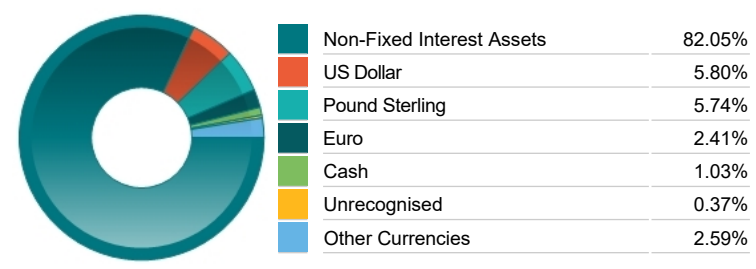
**Top Country Breakdown**



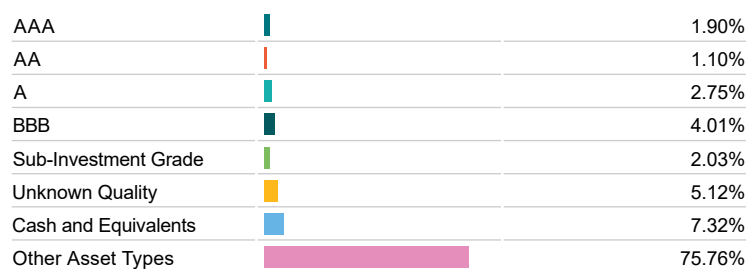
**Breakdown By Market Cap (%)**



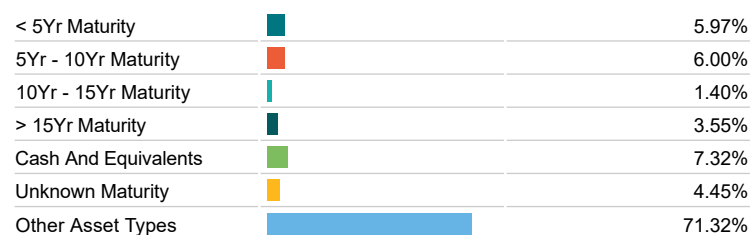
