

**Aims**

Objective: The investment strategy of the fund is to purchase units in the M&G PP Fixed Interest Fund - the underlying fund.

Underlying Fund Objective: The fund invests mainly in UK government gilts. The fund is actively managed against its benchmark, the iBoxx Sterling Gilts Index. The fund can also invest in overseas government bonds and corporate bonds issues by UK and overseas companies and institutions. Exposure to short-term exchange rate movements from any overseas holdings is mitigated by hedging.

Performance Objective: To outperform the benchmark by 0.75% a year (before charges) on a rolling three year basis.

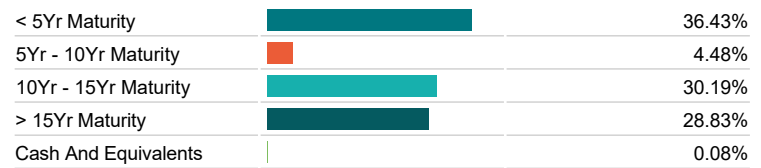

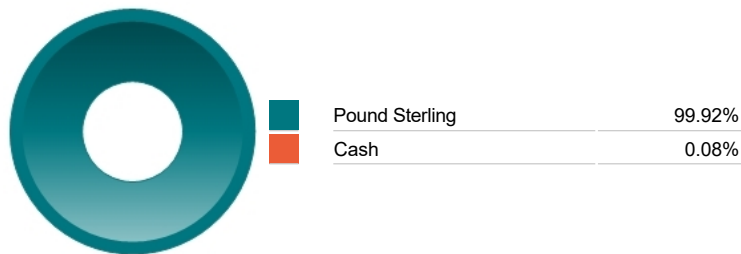
## Fixed Interest Quality Profile

## Commentary

Performance as at Q4 2025 - With the passage of the budget and the DMO's (Debt Management Office) decision to cancel part of its long dated issuance programme, long dated bonds performed strongly into year end. The fund's marginally long duration stance supported positive quarterly performance. This long duration position has since been scaled back. Over the quarter, the manager significantly reduced the fund's overweight position in index linked gilts. This allocation performed well and contributed positively to returns. A smaller overweight in 15-20 year index linked gilts remains in place.

Activity in the Fund continued to focus on an active stock specific relative value approach. The manager continues to position in the Fund in anomalously cheap securities along the gilt yield curve.
