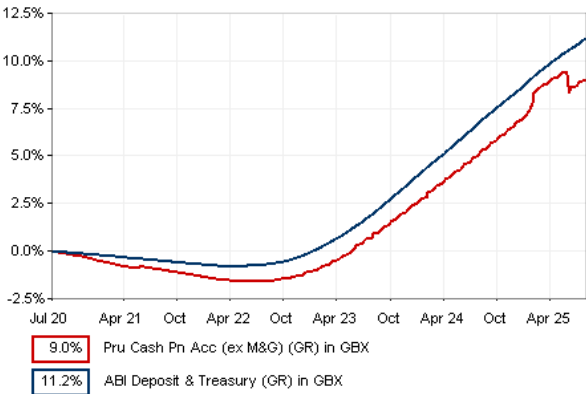

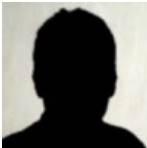

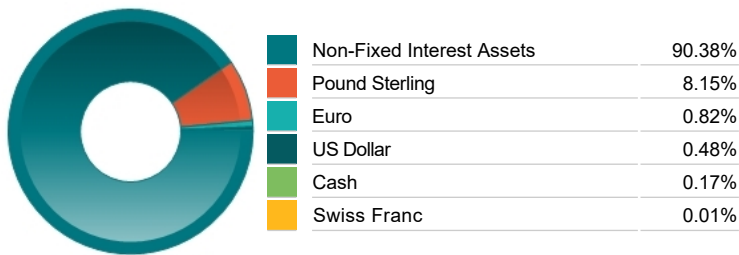
Equity Sector Breakdown
