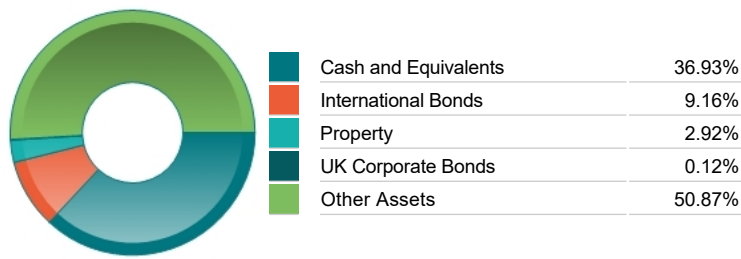

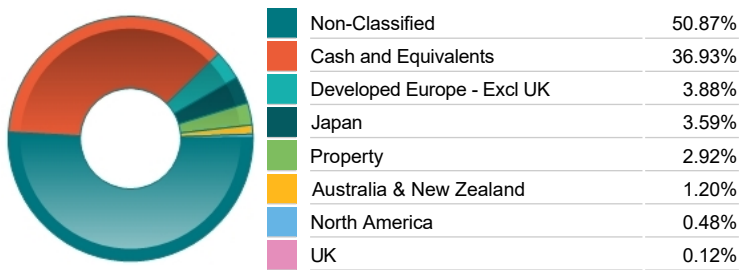

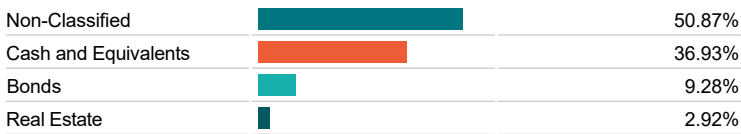

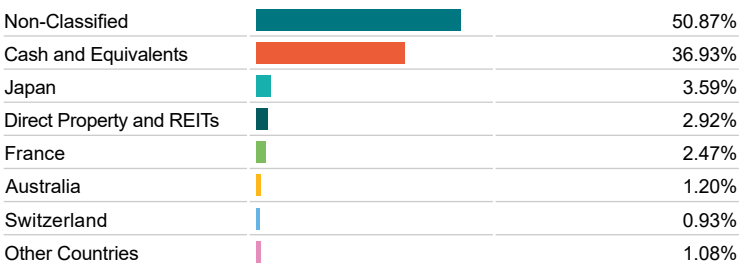

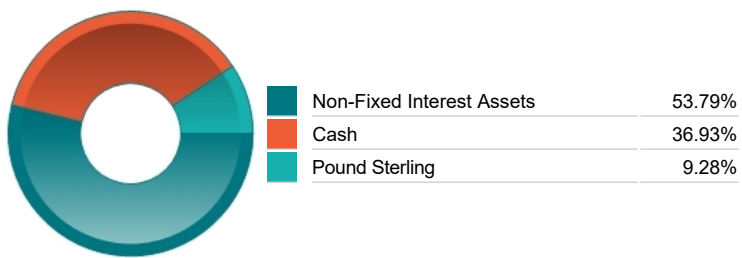
Sector Breakdown
