FUND AIM

The objective of this Fund is to provide a combination of income and capital growth by investing solely in the Legal & General UK Property Fund (the 'Master Fund'). It may also hold cash where necessary to enable the making of payments to unit holders or creditors.

The Manager has notified Shareholders in the Fund that a general meeting will be held on 10 April 2024 to consider proposed changes to the investment policy of the Master Fund. If this resolution is passed, the Master Fund will be permitted (among other things) to hold a larger proportion of its investments in global real estate investment trusts. The target date on which the proposed change will become effective, subject to Shareholders approval, is on or shortly after 12 April 2024.

FUND SNAPSHOT

- What does it invest in? Invests in UK office, retail, industrial and residential property. May also invest in other UK property related investments, such as shares in property companies and real estate investment trusts as well as hold cash
- How does it invest? Actively managed, aiming to solely invest in the Legal & General UK Property Fund but may also hold cash to maintain the liquidity of the fund.





WHO ISTHIS FUND FOR?

- This fund is designed for investors looking for growth and income from an investment in a balanced portfolio of predominantly UK Commercial Property and who are ineligible or unable to invest directly in the Master Fund.
- Although investors can take their money out at any time, this fund may not be appropriate for those who plan to withdraw their money within five years.
- This fund is not designed for investors who cannot afford more than a minimal loss of their investment.



KEY RISKS
