



Management process

- The management team (the "Team") use their discretion (active management) to identify a diverse

 result of this diversification, and during extreme equity market falls, we expect losses to be lower
 than those of the wider global equity markets.
- The Team select individual holdings depending on their prospects for growth and income and/ or creditworthiness (debt repayment ability) compared to that of the market based on expected future economic and business conditions.
- The Team separately conduct extensive research to identify the most appropriate type of investment for each asset class.

- (d) Private Markets Risk (UCITS funds) The fund invests in companies that are listed on stock markets. The value of these companies is driven by the growth and performance of the underlying private market assets in which they invest. These underlying private market assets do not trade on public markets therefore, valuation and pricing may be difficult to determine.
