To generate growth over the long term (5 years or more) by investing in equities (company shares) worldwide.

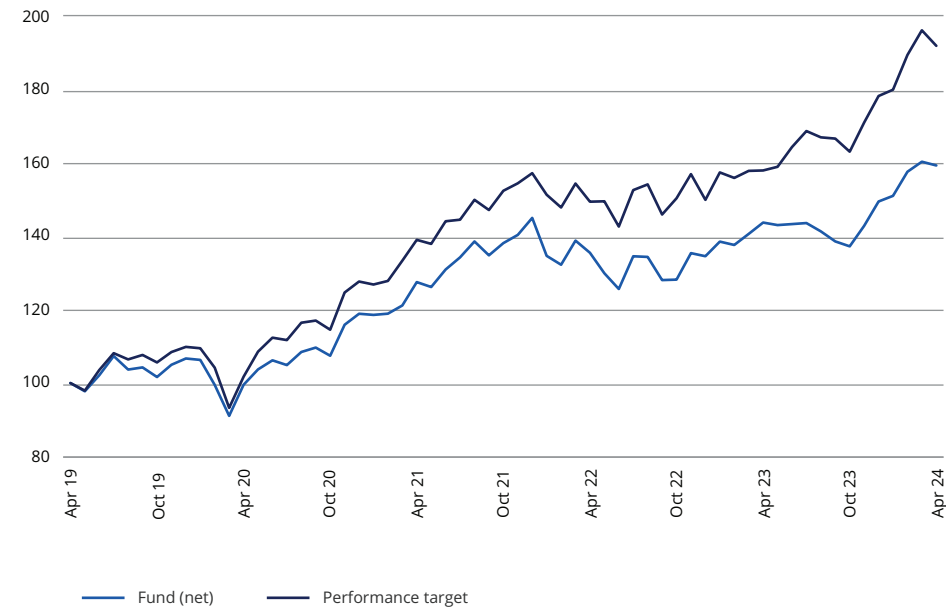
