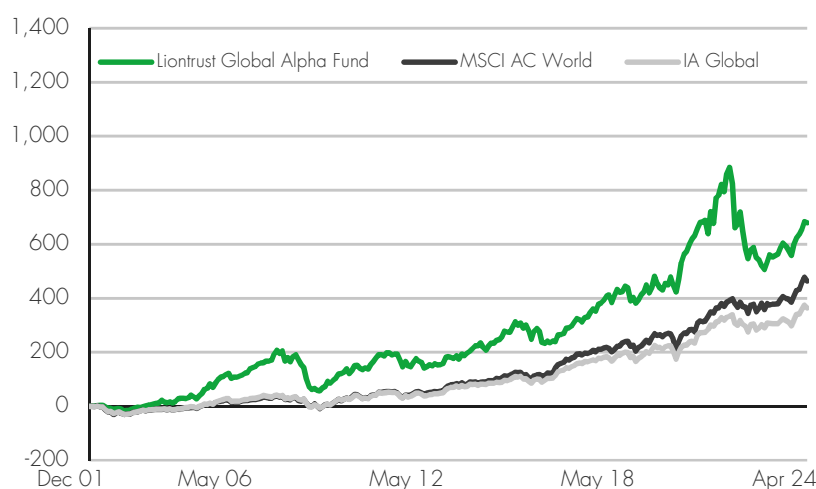

*The Ongoing Charges Figure (OCF) covers all aspects of operating a fund during the course of its financial year. The OCF **excludes** portfolio transaction costs except for an entry/exit charge paid by the Fund when buying or selling units in another fund. This will have an impact on the realisable value of the investment, particularly in the short term.
