### Objective

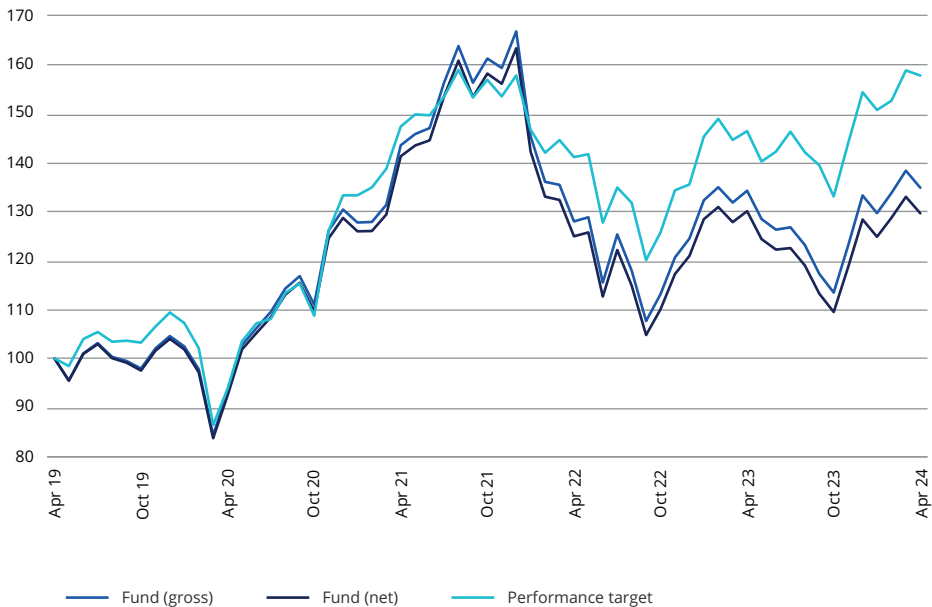
To generate growth over the long term (5 years or more) by investing in European smaller capitalisation equities (company shares).

**Performance Target:** To achieve the return of the MSCI Europe ex UK Small Cap Index, plus 3% per annum over rolling five year periods (before charges). There is no certainty or promise that the Performance Target will be achieved.  
The MSCI Europe ex UK Small Cap Index (the "Index") is a representative index of the stock market for European (excluding UK) smaller companies.

### Portfolio securities

- The fund will invest at least 70% in equities of European (excluding UK) smaller companies.
- European smaller companies are defined as any company of a size similar to those in the Index.
- The fund may also invest in larger European companies.
- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.
