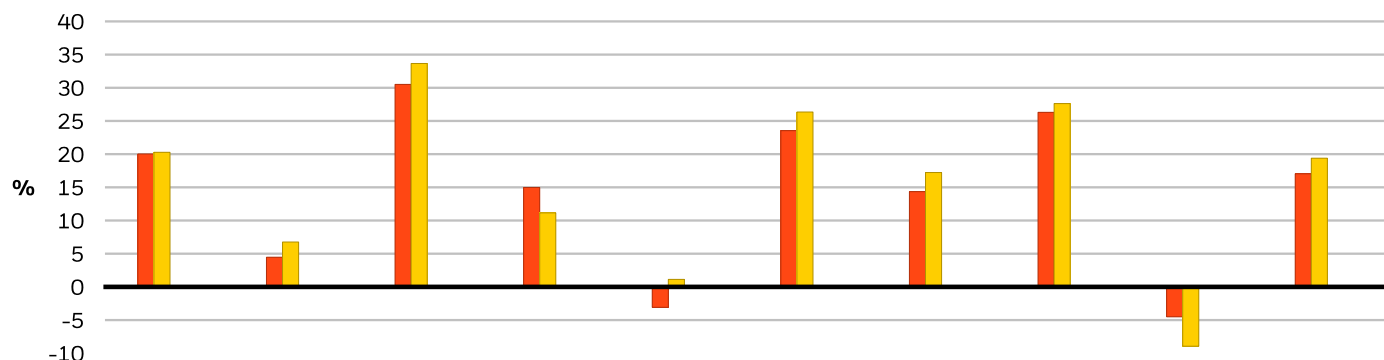

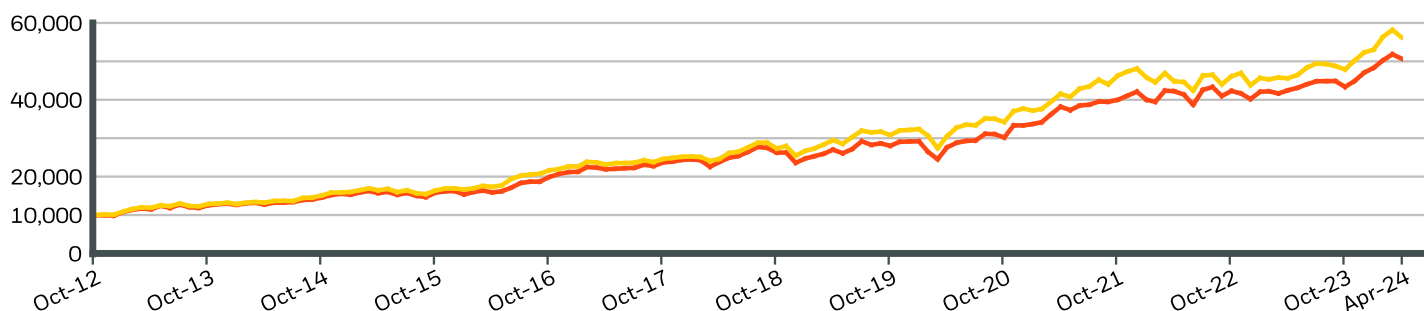

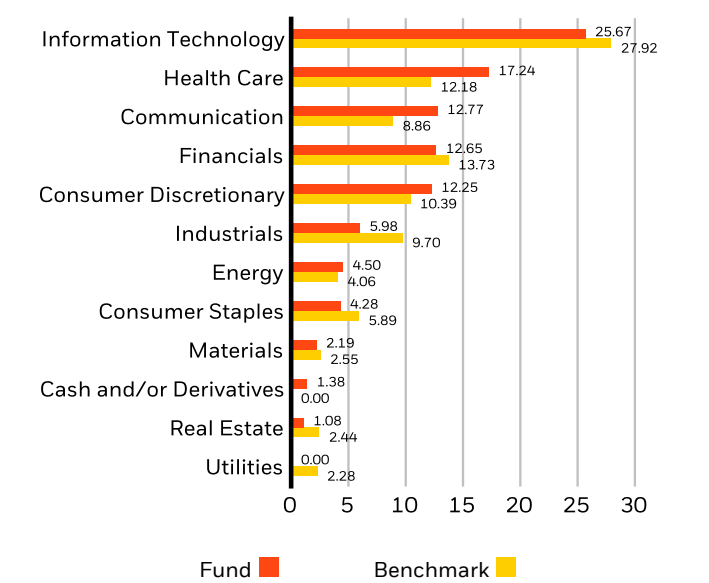

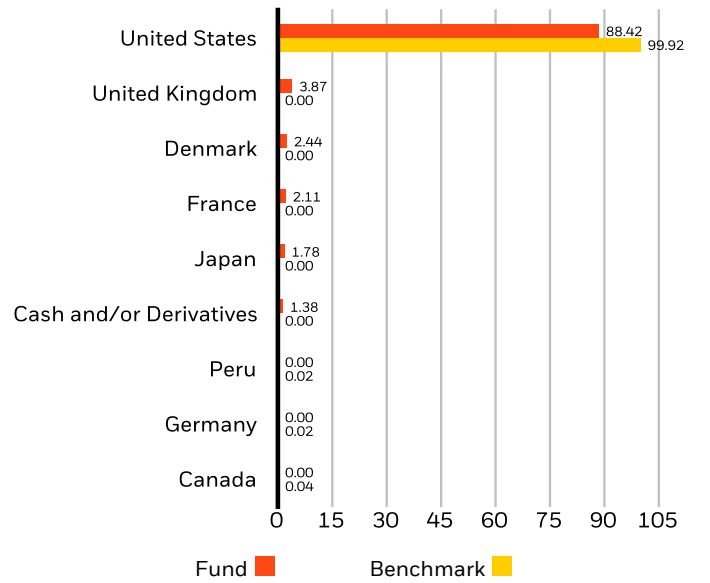

SECTOR BREAKDOWN (%)



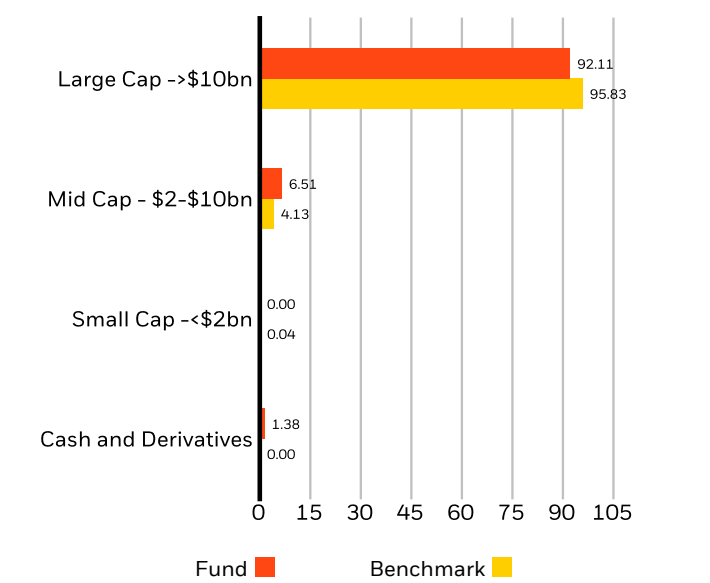
