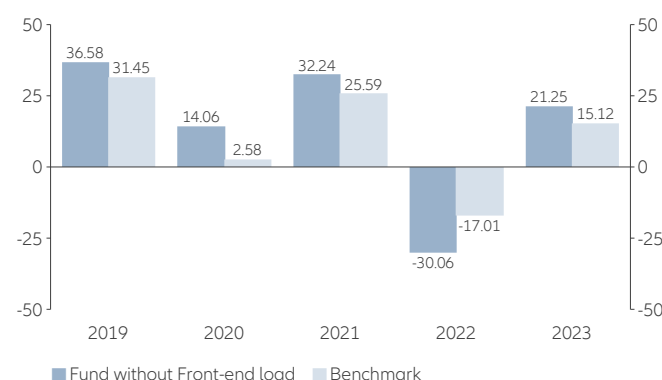

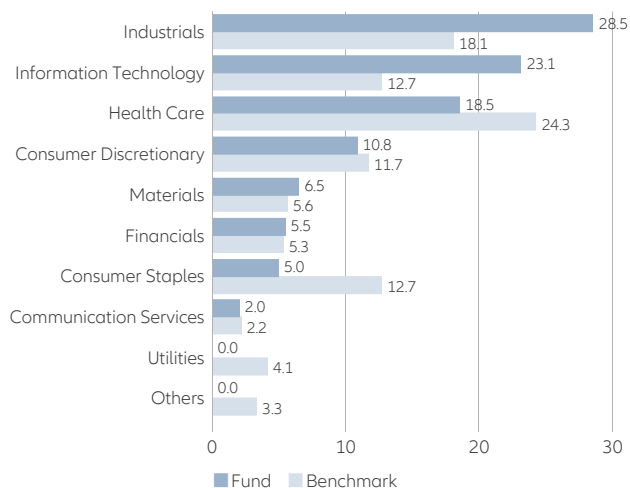

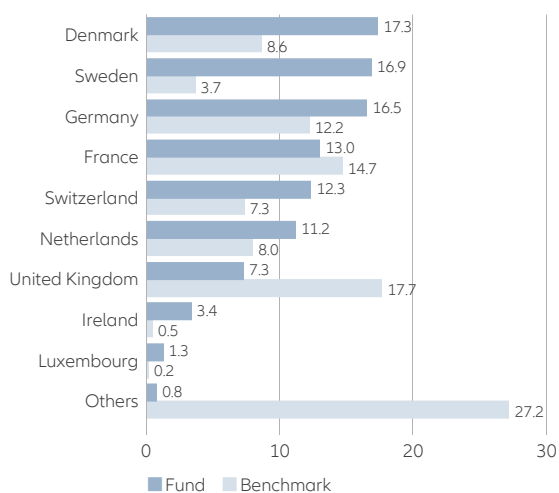
Sector Breakdown (%)
