The Authorised Corporate Director (ACD) of M&G Investment Funds (3) presents its interim report and unaudited financial statements for the six months ended 31 December 2022

The unaudited financial statements of M&G Investment Funds (3) and the investment report and unaudited financial statements and notes of each sub-fund are presented in their individual sections of this report as set out in the contents page.

Please note that we have included an explanation of key investment terminology in the 'Glossary' (at the back of this report).

Company information

M&G Investment Funds (3) is an umbrella Open-Ended Investment Company (OEIC) and contains seven sub-funds, hereinafter referred to as 'funds' in the rest of this report. Each fund is a UCITS (Undertakings for Collective Investment in Transferable Securities) scheme as defined in the Collective Investment Schemes sourcebook, as issued (and amended) by the Financial Conduct Authority (FCA). This OEIC is an Investment Company with Variable Capital (ICVC) incorporated under the Open-Ended Investment Companies Regulations 2001. It is authorised and regulated by the FCA under the Financial Services and Markets Act 2000.

The Company was authorised on 8 August 2001 and was launched on 7 March 2002, following the conversion of a series of authorised unit trusts.

The Company's principal activity is to carry on business as an OEIC. The Company is structured as an umbrella company, and different funds may be established by the ACD from time to time with the agreement of the Depositary and approval from the FCA. The funds are operated separately and the assets of each fund are managed in accordance with the investment objective and policy applicable to that fund.

As at 31 December 2022 none of the funds held shares of the other funds within this OEIC.

A shareholder is not liable for the debts of the Company and will never be liable to make any further payment to the Company after paying the purchase price of the shares.

Important information

COVID-19 continues to bring uncertainties. The ACD continues to monitor the ongoing operational risks that are posed to the Company and its service providers.

The events in Ukraine continue to shock and bring widespread condemnation. Western nations responded to Russia's attack which started on 24 February 2022, with sweeping sanctions: the US, the UK and the European Union have imposed sanctions on Russian

banks, state-owned enterprises (SOEs) and individuals with close links to President Putin.

From the perspective of financial markets, Russia's attack has sparked considerable volatility. There have been direct impacts, particularly with Russian exposed assets and indirect impacts affecting asset classes globally with commodity prices surging. Given the uncertainty around the continuing conflict, it is likely that financial markets will remain volatile as investors react to developments.

From 27 April 2022, the M&G Investments Thermal Coal Investment Policy has been applied. From January 2023 the Operating Charge figure will include the underlying charges for closed-ended funds, such as investment trusts and REITs (real estate investment trusts). There is no change to what you are currently being charged; this is a presentational change to align with the latest industry guidance issued by the Investment Association.

Financial statements and notes

The financial statements for M&G Investment Funds (3) comprise the individual financial statements for each fund and the notes below.

Notes to the financial statements Accounting policies

There are no material events that have been identified that may cast significant doubt on the Company's ability to continue as a going concern for at least the next twelve months from the date these financial statements are authorised for issue. The ACD believes that the Company has adequate resources to continue in operational existence for the foreseeable future and, they continue to adopt the going concern basis in preparing the financial statements. The ACD has made an assessment of each fund's ability to continue as a going concern which is made as at the date of issue of these financial statements and considers liquidity, declines in global capital markets, investor intention, known redemption levels, expense projections, key service provider's operational resilience, and the impact of COVID-19.

The interim financial statements have been prepared on the same basis as the audited financial statements for the year ended 30 June 2022, with the exception stated below. They are prepared under the historical cost convention, as modified by the revaluation of investments, and in accordance with the Statement of Recommended Practice (SORP) for Authorised Funds issued by the Investment Association in May 2014 and amended in June 2017.

At the end of the reporting period all investments have been measured at their fair value using the prices and the portfolio holdings determined at 12 noon on 30 December 2022, being the last valuation point of the accounting period. As this is materially different from the valuation carried out at close of business on the balance sheet date, a fair value accounting adjustment has been applied. No fair value adjustment was required for the previous reporting period as there was no material difference between the value of the

investments at 12 noon on 30 June 2022 and the valuation carried out at close of business on the balance sheet date.

Investments which have been subject to a fair value accounting adjustment at the balance sheet date have been translated into the fund's functional currency using the rate of exchange ruling as at close of business on the balance sheet date.

For the purposes of these financial statements, the Prospectus dated 31 October 2022 has been used.

Investment objective

The fund aims to provide a higher total return (the combination of capital growth and income), net of the ongoing charge figure, than the average return of the IA Sterling Corporate Bond sector over any five-year period.

Investment policy

At least 70% of the fund is invested, directly or indirectly through derivatives, in investment grade corporate debt securities including investment grade asset-backed securities. These securities can be issued by companies from anywhere in the world, including emerging markets. These securities are denominated in sterling or hedged back to sterling.

Other investments may include:

- debt securities issued or guaranteed by governments and their agencies, public authorities, quasi-sovereigns and supranational bodies and denominated in any currency;
- below investment grade and unrated debt securities;
- below investment grade and unrated asset-backed securities; and
- other transferable securities, cash, and near cash, directly or via collective investment schemes (including funds managed by M&G).

Investments in asset-backed securities are limited to 20% of the fund.

Derivatives may be used for investment purposes, efficient portfolio management and hedging.

Investment approach

The fund is diversified across a range of investment grade debt securities from a variety of sectors and geographies. The fund's investment approach is based on the principle that returns from corporate bond markets are driven by a combination of macroeconomic, asset class, sector, geographic and stock-level factors. As different factors dominate returns at different stages of the economic cycle, the fund manager applies a flexible investment approach, changing the blend of duration and credit exposure in the portfolio to weight them appropriately. Individual credit selection is carried out with the assistance of an in-house team of credit analysts to complement the fund manager's views.

Benchmark

Benchmark: IA Sterling Corporate Bond sector.

The benchmark is a target which the fund seeks to outperform. The sector has been chosen as the fund's benchmark as the fund is a constituent of the sector. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed.

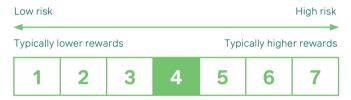
The fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund.

For unhedged share classes, the benchmark is shown in the share class currency.

Investment review

For the six months ended 31 December 2022

Performance against objective

Over the reporting period the fund delivered negative returns across all share classes, but outperformed its benchmark, the IA Sterling Corporate Bond Sector, which returned -4.1%.

The fund's objective is to provide a higher total return (the combination of capital growth and income), net of the ongoing charge figure, than the average of the IA Sterling Corporate Bond sector over any five-year period. The Sterling Class 'A' Accumulation and Sterling Class 'A' Income shares did not achieve this, but the others were above or level with the benchmark over five years. However, all share classes recorded negative returns over this period. The average return of the benchmark over the five-year period was -1.1% pa.

Performance review

Fixed income markets experienced significant volatility during the period under review as concerns over inflation, interest rates and growth persisted.

The first half of the review period delivered widespread poor performance as central banks hiked interest rates to counter rising inflation. The European Central Bank (ECB), for example, raised rates by a record 75 basis points (bps) in September. The war in Ukraine raged on, exacerbating already high food and energy prices.

Rising interest rates pushed down government bond prices, prompting yields to rise (bond yields move inversely to prices). Long-dated bonds are more sensitive to interest-rate changes than shorter-dated ones, which sparked a sell-off of 30-year US Treasuries and long-dated UK gilts. In the UK, bond markets crashed in September when the government's minibudget unsettled investors with unfunded tax cuts. As prices tumbled, the Bank of England (BoE) intervened by buying up bonds to calm the market.

Corporate bonds also struggled throughout the period. although banks and quality financial services, which can benefit from higher interest rates, fared better than

In this challenging environment, the best fixed income performance was to be found in inflation-linked bonds (where cashflows are adjusted in line with a measure of inflation, offering some protection from price rises) and certain high-yield bonds (which are less sensitive to interest rate changes than conventional ones).

The fourth quarter of the year had a brighter start: markets rallied in October and November amid hopes inflation may be peaking and interest rates about to fall. But the US Federal Reserve and ECB ended the period more hawkish on inflation and interest rates, and bonds fell again in December. The BoE was more dovish, expecting the UK's looming recession to reduce inflation.

The fund's core currency is sterling (GBP), whose underperformance negatively affected returns: the currency plummeted to a record low in September's mini-budget crisis. The US dollar (USD) was the best-performing currency, though weakening in December while the euro gained ground.

The yield curve (the relationship between bond maturity dates and yields) had the strongest negative effect on fund performance in the third quarter: long-dated bonds suffered most from rising interest rates. But improved sentiment in the fourth quarter reversed this trend, and the yield curve was a positive driver. Similarly, exposure to weak UK credit markets hurt performance in quarter three, but GBP financials and non-financial investment grade bonds bolstered the fourth quarter as markets recovered. USD holdings brought low or negative returns throughout, given the relative weakness of sterling.

One of the key drivers of a bond fund's performance is its ability to adjust the portfolio's sensitivity to changes in interest rates, known as 'duration' and measured in years. The fund had a slightly shorter duration position than the iBoxx Sterling Corporate Index during the review period: this means it was relatively less sensitive to interest rate changes than investments with longer durations. With the price of major government bonds falling during the year, this was a very small benefit to fund performance.

Investment activities

Investment-grade corporate bonds (those issued by quality providers with a low risk of default) made up 81% of the portfolio at 31 December, up from 76.5% at the beginning of the review period. We maintained a cautious view of credit, selling out of some higher-risk assets as credit spreads widened towards the end of the period. We believe financials will be among the best performers in a high-rate environment: over the course of 2022, they outperformed industrials by around 10%.

Government bonds accounted for just under 5% of the portfolio as at 31 December, down from just over 7% at the start of the review period.

Given market volatility, we increased duration to 6.5 years in the third quarter, slightly overweight the market for the first time since 2008, before reducing it to around 6.0 years in December.

Outlook

We are clearly not out of the woods yet when it comes to inflation and interest rates. In the US, the widely predicted recession may yet be avoidable, given the strength of the labour market, but the UK is likely to face a slower recovery, with Brexit and recent political upheaval both playing a part.

That said, we believe companies are in better shape than before the last recession, with stronger balance sheets leading to fewer defaults. We will continue to focus on mispriced bonds in companies we know and understand, including quality financials and the US blue chips that can best weather a downturn.

Notes to the financial statements

Accounting policies

The financial statements have been prepared in accordance with the 'Accounting policies' set out on page 5.

Distribution policy

In determining the amount available for distribution to Income shares, the annual charge is offset against capital, increasing the amount available for distribution whilst restraining capital performance to an equivalent extent.

For the purposes of these financial statements, the Prospectus dated 31 October 2022 has been used.

Investment objective

The fund has three aims:

- To provide an annual yield higher than that of the FTSE All-Share Index;
- To provide an income stream that increases every vear;
- To provide a higher total return (the combination of capital growth and income), net of the ongoing charge figure, than that of the FTSE All-Share Index over any five-year period.

Investment policy

At least 70% of the fund is invested in equity securities and equity-related securities of companies across any sector and market capitalisation, that are incorporated, domiciled, listed or do most of their business in the United Kingdom.

The fund may also invest in other transferable securities, including the shares of non-UK companies, cash and near cash directly or via collective investment schemes (including funds managed by M&G).

Derivatives may be used for efficient portfolio management and hedging.

Investment approach

The fund employs a disciplined approach to investment which concentrates on the analysis and selection of individual companies. The fund typically invests in a well-diversified portfolio of high-yielding UK stocks. The yield premium attached to the fund generally means that there is a bias towards good value, out of favour stocks (ie those stocks which the fund manager considered to be undervalued by the market). The emphasis on yield helps to identify stocks that are relatively cheap and to avoid those that are expensive. From the universe of high yielding stocks, the fund

manager identifies companies that are competitive, with a strong business franchise and that have attractive dividend growth prospects.

Benchmark

Benchmark: FTSE All-Share Index.

The benchmark is a target which the fund seeks to outperform. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed.

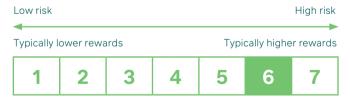
The fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents.

Investment review

For the six months ended 31 December 2022

Performance against objective

Over the period, the fund has achieved two of its three aims. The fund achieved the objective of growing its income distribution over the six-month review period. The fund distributed income of 0.77p per Sterling Class 'A' Income share, an increase of 2.0% over the 0.75p payment made in the same period a year earlier.

On 3 January 2023, the fund's Sterling Class 'A' Income shares yielded 5.70%. That was above the benchmark FTSE All-Share Index yield of 3.59%, meeting the fund's objective to exceed the index yield. Over five years, the fund delivered positive returns across all its share classes but has lagged the benchmark FTSE All-Share Index in total return terms (the combination of capital growth and income), thereby missing its objective of outperforming the benchmark. Over this period, the index returned 2.9% pa.

For the performance of each share class, please refer to the 'Long-term performance by share class' table in the 'Fund performance' section of this report.

Performance review

The fund made positive gains in the second half of 2022, while trailing the UK stockmarket as measured by the FTSE All-Share Index. Returns lagged behind in the third quarter because the defensive portfolio missed out on a July rally. However, performance surpassed the index in the fourth quarter and across the full calendar year.

Marketwide, UK equities made gains through mid-August followed by a sell-off over the next couple of months before a rebound from October. Late September saw a period of particular market turbulence after new Prime Minister Liz Truss's government unveiled a mini-budget which unnerved investors, causing a slump in sterling and a surge in borrowing costs. Markets steadied after intervention by the Bank of England (BoE) and by Truss's replacement Rishi Sunak.

Throughout the period, markets were shaped by soaring inflation, rising interest rates and a cost-ofliving squeeze. Prices surged amid the continuing fallout from Russia's invasion of Ukraine, and subsequent efforts to boycott Russian oil and gas in Europe. Global supply chains were also still returning to normal following COVID-19. The BoE raised rates four times in the second half of the year in a bid to stifle price increases, and other global central banks made similar moves

UK stocks were shielded from the worst of these headwinds because the market is dominated by value stocks, such as banks and miners. These companies reward shareholders with dividends today rather than the promise of profits in the years ahead. By contrast, growth stocks, notably technology companies, suffered elsewhere in the world as inflation dented the value of their future earnings. UK lenders also benefited from rising interest rates, while miners and oil producers gained from higher commodity prices. Weak sterling was a further benefit to companies with overseas sales.

These trends meant that within the UK, large global companies outperformed smaller and more domestically-focused businesses during the review period. The FTSE 100 Index, which tracks the biggest UK stocks, beat the FTSE All-Share Index, while the mid-size FTSE 250 Index and the FTSE Smaller Companies Index (ex Investment Trusts) both underperformed. Investment decisions meant that the fund's FTSE 250 picks outperformed their index. Smallcap selections underperformed, while large-cap returns were broadly in line with the FTSE 100.

In terms of industry selection, the fund underperformed the benchmark. Consumer discretionary was the biggest drag as the fund's holdings made a loss even though the sector overall beat the index. Basic materials hurt as the fund had a below-index position in a sector that outperformed. The fund also had an above-index position in real estate, which made a loss. There were beneficial asset allocations in technology, energy and consumer staples.

At the stock level, some of the fund's biggest contributors were the oil and gas companies BP and Shell, and miner Rio Tinto. Technology company Micro Focus and sausage-skin maker Devro both made outsized contributions after takeover offers. Cigarette maker Imperial Brands was also among the top returns following a share buyback announcement. It was joined by packaging group DS Smith, which posted a profit surge. Among smaller companies, newspaper publisher Reach was boosted in the fourth quarter by an ultimately aborted takeover bid. Fund managers Abrdn and Ashmore benefited from increased assets under management.

The biggest drag on the fund at the company level was Vodafone. The mobile-phone operator lowered its full-year outlook, parted with its CEO and suffered concerns about a potential dividend cut. Drugmaker GSK weighed as it contended with lawsuits tied to the heartburn drug Zantac. Asset manager Pollen Street, homebuilders Watkin Jones and Vistry, and social-housing owner Home REIT were also among the worst performers.

Investment activities

The fund gained a new holding in July as GSK (formerly GlaxoSmithKline) demerged its consumer health division Haleon. The new company went straight into the FTSE 100.

Commodities-ship operator Pacific Basin was added to the portfolio in August due to an attractive yield. Bulkshipping is a key part of the global economy, and the sector has been suffering capacity shortages.

In September, the fund reopened a position in furniture retailer Dunelm. The company is well managed and offers attractive yields. Its stock had suffered because of concerns about the UK economy. Later in the year, the fund returned to Marshalls, also due to an attractive yield. The paving maker had exited the portfolio some time earlier at much higher levels. Transport operator Go-Ahead departed following the completion of a takeover.

Across the review period, the fund's biggest net purchase was telephone company BT, which rose to

0.76% of holdings from zero. Other notable net buys include investment managers Hargreaves Lansdown and Abrdn, plus UK banks NatWest and HSBC. The most actively sold stocks were BP, Micro Focus, property owner Warehouse REIT, investment manager Schroders, and insurers Aviva and Legal & General.

Outlook

UK stocks are much better positioned now than ahead of the 2008 global financial crisis, which we believe should support the market amid likely 2023 economic weakness. Balance sheets have been greatly strengthened, including a notable improvement in bank capitalisation due to tougher regulations. That should help lenders ride out any increases in bad debts. Miners are similarly much less indebted than before the global financial crisis.

Many companies in the FTSE All-Share Index are also cushioned against UK headwinds as their revenue is mostly derived from overseas markets. The disproportionate weighting of oil companies, miners, pharmaceutical companies and tobacco stocks means that the market benefits from a stronger dollar. These four sectors and banks will likely pay just over 50% of all UK dividends in 2023.

Furthermore, weak sterling should support more acquisitions of UK companies by overseas buyers. This is likely to happen in mid-cap stocks and potentially in the FTSE 100 as well. The fund would likely be an unwilling seller because valuations are depressed and we are reluctant to exit valuable businesses even if there are short-term economic headwinds.

Authorised Corporate Director's Report

In terms of dividends, total market-wide payouts might make only modest progress in 2023 because of reductions in mining dividends and one-off payouts. UK dividends will likely only regain their pre-pandemic highs in 2024.

Notes to the financial statements

Accounting policies

The financial statements have been prepared in accordance with the 'Accounting policies' set out on page 5.

Distribution policy

In order to conduct a controlled dividend flow to shareholders, interim distributions will be at the fund manager's discretion, up to the maximum of the distributable income available for the period.

In determining the amount available for distribution to Income shares, the annual charge is offset against capital, increasing the amount available for distribution whilst restraining capital performance to an equivalent extent.

Authorised Corporate Director's Report

For the purposes of these financial statements, the Prospectus dated 31 October 2022 has been used.

Investment objective

The fund aims to provide a higher total return (the combination of capital growth and income), net of the ongoing charge figure, than that of a composite index* over any five-year period.

* The composite index is made up of one third JPM EMBI Global Diversified Index, one third JPM CEMBI Broad Diversified Index and one third JPM GBI-EM Global Diversified Index.

Investment policy

At least 80% of the fund is invested, directly or indirectly through derivatives, in emerging market debt securities. These securities can be issued or guaranteed by emerging market governments and their agencies, public authorities, quasi-sovereigns, supranational bodies and companies that are incorporated, domiciled, listed or do most of their business in emerging markets. These securities can be denominated in any currency, including emerging market currencies.

Other investments may include:

- asset-backed securities; and
- other transferable securities, cash, and near cash, directly or via collective investment schemes (including funds managed by M&G).

There are no credit quality restrictions applicable to the fund's investments.

Derivatives may be used for investment purposes, efficient portfolio management and hedging.

Investment approach

The fund is globally diversified across a range of emerging market debt securities and issuers from a variety of sectors and geographies. The fund's investment approach is flexible and begins with an assessment of macroeconomic factors such as global risk appetite and the catalysts of global economic growth.

On a regional and country-specific level, factors such as monetary and fiscal policies, capital flows, and political and regulatory environments are assessed. The result of this analysis will help inform the country, currency allocations and duration of the portfolio.

Individual credit selection is carried out with the assistance of an in-house team of credit analysts to complement the fund manager's views.

Benchmark

A composite index comprising:

- 1/3 JPM EMBI Global Diversified Index.
- 1/3 JPM CEMBI Broad Diversified Index.
- 1/3 JPM GBI-EM Global Diversified Index.

The benchmark is a target which the fund seeks to outperform. The composite index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark does not constrain the fund's portfolio construction.

The fund is actively managed.

The fund manager has complete freedom in choosing which assets to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents.

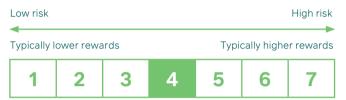

Investment review

For the six months ended 31 December 2022

Performance against objective

Between 1 July 2022 and 31 December 2022, the fund delivered a strong positive total return (the combination of income and growth of capital) across its sterling share classes. The fund outperformed its benchmark, which returned 3.8% over the same period.

The fund's benchmark is a composite index consisting of 1/3 JPM Emerging Markets Bond (EMBI) Global Diversified Index, 1/3 JPM Corporate EMBI (CEMBI) Broad Diversified Index, and 1/3 JPM GBI-EM Global Diversified Index.

Over five years, the fund's unhedged share classes achieved its objective of providing a combination of capital growth and income, net of the ongoing charge figure, higher than the benchmark composite index over any five-year period. The return of the benchmark

composite index was 1.5% pa over this period. The fund's hedged share classes posted a negative return over five years.

For the performance of each share class, please refer to the 'Long-term performance by share class' table in the 'Financial highlights' section of this report.

Performance review

Following a dismal first half of the year, the outlook for emerging market debt continued to worsen at the start of the second half, as investors feared that sharp rises in interest rates would eventually lead to a slowdown in global economic activity. Furthermore, higher food and energy prices in emerging countries pushed up inflation expectations, causing a spill over into the prices of other goods and services. Most developing countries responded with interest rate hikes, but these struggled to keep pace with double-digit inflation. A strong dollar exacerbated the situation, resulting in a flight of capital to US government bonds (Treasuries), especially into those with a shorter time until they became eligible to be repaid (maturity).

However, by the fourth quarter, risky assets had rallied following better-than-expected inflation data in the US and unexpected announcements of slower interest rate hikes by the major central banks. Emerging markets debt was one of the best performing asset classes as markets rebounded strongly in the quarter. Local currency sovereign debt outperformed the other segments of the asset class.

Against this backdrop, the fund delivered a strong positive return over the period and outperformed its benchmark significantly. This was achieved through overweight duration and spread duration positioning in a period of falling bond yields and credit spreads compression, especially in the fourth quarter.

Our hard currency assets outperformed as sovereign bonds positively contributed to performance. In local currency, government bonds contributed positively following weakness of the dollar against most emerging currencies, while corporate bonds marginally contributed during the whole period.

Authorised Corporate Director's Report

Our country allocation decisions contributed positively, primarily in the local currency markets. Brazil and Mexico added value (although Mexico detracted in the third quarter of the year), while having no exposure to Egypt aided relative returns.

Investment activities

There were no major changes in the fund positioning, with hard currency assets making up around two-thirds of assets during the review period. Nevertheless, we moved into an overweight (above-benchmark) position in local currency assets as hard currency assets lagged in a rising yield and stronger dollar environment.

Sovereign bonds continued to be sold-off significantly in the period, with several weaker issuers already trading at levels lower than their potential recovery value (the value which investors would be expected to recover in case the issuer of the bond became unable to repay the interest or principal in full). We reduced or closed our exposure to issuers where we had serious concerns over fundamentals (fundamentals have to do with issuer conditions such as cash flows, earnings or income, other debt, etc). For example, in July, we reduced our position in Armenia due to concerns over the country's fundamentals. Other sovereign issue positions trimmed during the period included Bahrain, Bolivia, and Romania.

In hard currency bonds, we increased our exposure to larger economies in Latin America and Eastern Europe. We added dollar sovereign bonds from Panama, Colombia and Poland in November. Although there was a dearth of new bond issues, we managed to participate in new sovereign issues from Bulgaria and Romania in September.

Within local currency assets, we reduced our overall positions by October, including exiting a position in Chinese government bonds given our concerns over economic growth. Following a sharp sell-off in South Korean domestic bonds, we added several high-quality Asian financials at what we considered to be attractive valuations.

In August, we took the opportunity of strong performances to trim our exposure to Enfragen Energia

(Colombia), VTR (Chile) and KOS (Ghana). Towards the end of the period, we reduced Brazilian car rental operator Simpar and investment management company XP over valuation concerns.

Outlook

Although inflation looks like it has peaked in several emerging market countries, and benchmark local interest rates are at high levels, prices might still rise should looser monetary conditions once again prevail.

We expect there is strong potential for a synchronised boom in Asian economies following the relaxation of China's zero COVID-19 policy. Therefore, we anticipate significant divergence in the performance of emerging market debt among different regions in 2023, which in our opinion should provide opportunities for relative value trades.

Finally, we think valuations remain attractive while yields are at levels which, in the past, were consistent with subsequent higher returns.

Notes to the financial statements

Accounting policies

The financial statements have been prepared in accordance with the 'Accounting policies' set out on page 5.

Distribution policy

In determining the amount available for distribution to Income shares, the annual charge is offset against capital, increasing the amount available for distribution whilst restraining capital performance to an equivalent extent.

For the purposes of these financial statements, the Prospectus dated 31 October 2022 has been used.

Investment objective

The fund aims to provide a higher total return (the combination of capital growth and income), net of the ongoing charge figure, than that of the ICE BofAML Euro Corporate Index over any five-year period.

Investment policy

At least 70% of the fund is invested, directly or indirectly through derivatives, in investment grade corporate debt securities. These securities can be issued by companies from anywhere in the world, including emerging markets. These securities can be denominated in any European currency.

Other investments may include:

- below investment grade and unrated corporate debt securities;
- debt securities issued or guaranteed by governments and their agencies, public authorities, quasi-sovereigns, supranational bodies;
- asset-backed securities; and
- other transferable securities, cash, and near cash, directly or via collective investment schemes (including funds managed by M&G).

At least 70% of the fund is in euro or hedged back to euro.

Derivatives may be used for investment purposes, efficient portfolio management and hedging.

Investment approach

The fund is predominantly diversified across a range of euro denominated investment grade debt securities from a variety of sectors and geographies. The fund's investment approach is based on the principle that returns from corporate bond markets are driven by a combination of macroeconomic, asset class, sector, geographic and stock-level factors. As different factors dominate returns at different stages of the economic cycle, the fund manager applies a flexible investment approach, changing the blend of duration and credit exposure in the portfolio to weight them appropriately.

Individual credit selection is carried out with the assistance of an in-house team of credit analysts to complement the fund manager's views.

Benchmark

Benchmark: ICE BofAML Euro Corporate Index.

The benchmark is a target which the fund seeks to outperform. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed.

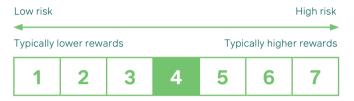
The fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents.

Investment review

For the six months ended 31 December 2022

Performance against objective

Between 1 July 2022 (the start of the review period) and 31 December 2022, the M&G European Corporate Bond Fund delivered a positive total return (the combination of income and growth of capital) across all share classes, aside from the Class 'I-H' Income shares.

Fund performance for the other share classes was roughly in line with the fund's benchmark, the ICE BofAML Euro Corporate Index, which returned 1.0% in sterling terms over the period.

Over five years, the fund generated a negative total return across all share classes, and it lagged the benchmark's average return of -1.7% pa in sterling. Therefore, the fund did not meet its objective of providing a higher total return, net of the ongoing

charge figure, than the average return of the ICE BofAML Euro Corporate Index, over any five-year period.

For the performance of each share class, please refer to the 'Long-term performance by share class' table in the 'Financial highlights' section of this report.

Performance review

Financial markets were constrained in the second half of 2022 amid inflationary pressures stemming from Russia's invasion of Ukraine, higher global interest rates and rising economic concerns. Sterling also suffered a rout after the government's mini-budget in September unnerved investors.

Global government bond yields generally widened compared to corporate bond yields in the six months through to December, due to high inflation and rising interest rates amid an economic slowdown. Inflation reflects the pace of increase in the cost of goods and services. It is traditionally bad for bonds because it erodes the value of the fixed payments that bondholders receive from debt issuers.

Euro-denominated corporate bonds suffered three losing months out of six, based on the fund's benchmark. That capped the worst year for euro investment grade bonds since the creation of the single currency in 1999. Still, US and European investment grade and high yield credit posted positive returns in the fourth quarter, even with a dip toward year-end. The performance partly reflected expectations for interest rates – investor optimism about a slowdown in rate increases was dented by continued high inflation. Credit spreads widened in the third quarter and tightened in the fourth. Spreads are a measure of the compensation that investors demand to hold corporate debt instead of safer government bonds.

Energy costs fuelled inflation as European countries sought to pare back their reliance on Russian oil and gas following Russia's invasion of Ukraine. Governments shielded consumers and businesses from the worst of the price surge through subsidies or price caps, easing the inflation spiral. Central banks raised interest rates in a bid to cool business and consumer spending, and

thereby temper price rises. The European Central Bank (ECB) ended eight years of negative interest rates in July, starting a run of four rate increases through to year-end. September's record 75 basis points increase had a strong negative impact on bonds, particularly as policymakers warned about more hikes to come. A similar rate rise in November had a more muted impact. Indeed, risk assets rallied as investors focused on the prospect of a slowdown in increases.

Sterling plunged in late September after the UK government unveiled a raft of unfunded spending plans. The currency sell-off and a surge in bond yields (which move in the opposite direction to prices) prompted market intervention by the Bank of England (BoE). The pound pared back its losses against the euro through to the end of December, following the unravelling of the fiscal plan and the resignation of Prime Minister Liz Truss.

The year ended with the BoE and ECB both announcing December increases in benchmark borrowing costs. The central banks both said their local economies had likely contracted in the fourth quarter of 2022, and also highlighted negative outlooks for the start of 2023. Inflation was about 10% in both markets in November, marking only a slight slowdown from October.

Security selection was beneficial to fund performance in both the first and second half of the review period. Oil and gas company TotalEnergies and real estate owner Adler were notable winners in the third quarter, followed by telecom tower owner Cellnex Telecom and Alstria Office REIT in the fourth quarter. However, in the third quarter, allocations to asset-backed securities (for instance, debt tied to car loans), real estate and sovereign government debt hampered fund performance. Sovereigns, utilities and derivatives also held back fund performance in the fourth quarter.

The fund started the review period short duration versus the benchmark (meaning the fund was less sensitive to interest rate changes than the benchmark index), moved to longer duration in the following months and then back to short. It ended December 0.2 years underweight, relative to the fund's

benchmark, at 4.4 years. Credit spread duration – the extent to which the portfolio is exposed to corporate bond risk – was relatively steady throughout the period. It was 4.5 years at year-end, or 0.2 years underweight, more conservative than the index in terms of credit risk.

Investment activities

Across the period, the fund notably increased its exposure to utilities, cash and banking, while reducing energy, healthcare and telecommunications. In August, the fund added utilities, like EON and EWE, as considerable widening of spreads had made the sector good value. More utility bonds were added later in the review period in both the new-issuance and secondary markets. The fund took advantage of a busy November for the primary market by adding insurance (Great Western Lifeco, MetLife) and banks (Credit Suisse) and maintaining an overweight position, relative to the benchmark, in real estate investment trusts (REITs). Bank bonds (Barclays, BPCE) were also added via the secondary market. The fund sold telecommunication hybrid bonds (Orange, Vodafone) and BBB-rated debt (Informa, GM, Volkswagen) the same month. (BBB bonds are at the low end of investment grade.) At the end of December, investment-grade bonds accounted for more than 80% of fund assets. The biggest countries of risk were the US, France, Germany and the UK.

Authorised Corporate Director's Report

Outlook

Heading into 2023, the global economy is slowing. Europe is probably already in a recession – potentially a shallow one – and it faces energy challenges. Around the world, central banks will likely reach terminal interest rates at different times, leading to desynchronisation between developed markets. Still, fixed-income valuations look appealing, in our view, as wider credit spreads have created fair to attractive valuations.

Notes to the financial statements

Accounting policies

The financial statements have been prepared in accordance with the 'Accounting policies' set out on page 5.

Distribution policy

In determining the amount available for distribution to Income shares, the annual charge is offset against capital, increasing the amount available for distribution whilst restraining capital performance to an equivalent extent.

For the purposes of these financial statements, the Prospectus dated 31 October 2022 has been used.

Investment objective

The fund aims to provide a higher total return (the combination of capital growth and income), net of the ongoing charge figure, than the average return of the IA Global Government Bond sector over any five-year period.

Investment policy

At least 70% of the fund is invested, directly or indirectly through derivatives, in investment grade debt securities. These securities can be issued or guaranteed by governments and their agencies, public authorities, quasi-sovereigns, and supranational bodies from anywhere in the world, including emerging markets. These securities can be denominated in any currency.

Other investments may include:

- below investment grade debt securities, issued or guaranteed by governments and their agencies, public authorities, quasi-sovereigns and supranational bodies;
- asset backed securities; and
- other transferable securities, cash, and near cash, directly or via collective investment schemes (including funds managed by M&G).

Derivatives may be used for investment purposes, efficient portfolio management and hedging.

Investment approach

The fund is globally diversified across a range of government debt securities and issuers from a variety of sectors and geographies. The fund's investment approach is flexible and begins with an assessment of macroeconomic factors such as expectations on interest rates, inflation and economic growth.

On a regional and country-specific level, factors such as monetary and fiscal policies, capital flows, and political and regulatory environments are assessed. The result of this analysis helps to inform the country, currency allocations and duration of the portfolio.

Individual credit selection is carried out with the assistance of an in-house team of credit analysts to complement the fund manager's views.

Benchmark

Benchmark: IA Global Government Bond sector.

The benchmark is a target against which the fund seeks to outperform. The sector has been chosen as the fund's benchmark as the fund is a constituent of the sector. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed.

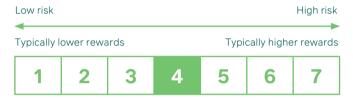
The fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund.

Investment review

For the six months ended 31 December 2022

Performance against objective

Between 1 July 2022 (the start of the review period) and 31 December 2022, the M&G Global Government Bond Fund delivered positive performance across its sterling share classes. Returns were negative for the fund's benchmark, the IA Global Government Bond Sector, over the same period.

For the five-year period, the fund did not meet its objective, which is to provide a combination of capital growth and income, net of the ongoing charge figure, higher than that of the average return of the IA Global Government Bond Sector over any five-year period. Across all share classes, the fund's returns matched or trailed the benchmark's 0.1% pa return.

For the performance of each share class, please refer to the 'Long-term performance by share class' table in the 'Financial highlights' section of this report.

Performance review

The six-month period under review was volatile for fixed-income markets as central banks raised interest rates, inflation remained high and the global economy cooled. Investor sentiment, and expectations of the peak for future rate rises, also swung as new data emerged.

The US Federal Reserve (Fed) raised its benchmark rate four times in the second half of the year - following three increases in the first six months - as central banks sought to drain money from the economy in a bid to cool price rises. The hikes meant that the benchmark US rate ended the year at 4.25% to 4.5%, more than four percentage points higher than at the start of 2022. The Bank of England (BoE) raised rates four times from July to December and the European Central Bank (ECB) also implemented four increases as it ended eight years of negative borrowing costs.

Inflation reached multi-decade highs in 2022, largely due to surging energy costs and long-term disruptions following COVID-19 lockdowns. The increase in energy prices followed European nations boycotting Russian oil and gas after Russia's invasion of Ukraine. Inflation is bad for bonds because it reduces the present value of future debt payments.

The value of sterling and UK government debt slumped after the government's growth-focused mini-budget in late September sparked concerns about increased state borrowing. The BoE intervened to shore up markets, and Prime Minister Liz Truss eventually resigned amid market and political turmoil. UK asset values recovered somewhat with the arrival of a more market-friendly prime minister.

Yields on 10-year US Treasuries widened in the period through to mid-November before easing into year-end. Yields move inversely to prices and they measure returns for bondholders. German 10-year bund yields eased into August before generally widening for the rest of the year.

Global investment grade bonds, which carry lower risk, fell in the second half of 2022 as the central programme of rising interest rates continued.

In currencies, the US dollar index rallied through November before its gains were erased by the end of the year. Sterling ended the six months little changed against the euro, after recovering losses.

The fund maintained a globally diversified portfolio of government bonds across developed and emerging markets during the period. The balance shifted further toward developed market currencies over the period to end December at 77% of the portfolio, slightly up from 71% at the start of the period. The fund benefited from being overweight to dollar duration, meaning that it increased its sensitivity to dollar interest rates versus the benchmark. Being underweight duration and the currency exposure in yen, euros and pounds helped across the review period.

Investment activities

The fund started selling Chinese government bonds in July and had exited the entire position by the end of November. The move reflected geopolitical concerns and expectations that China's central bank would change its accommodative strategy as the economy began to recover from COVID-19 lockdowns. It was also expected to issue more debt to help support local governments.

Italian exposure was cut to zero by early August amid political instability. Short positions in short-dated debt, including two-year US Treasuries, were closed in August and September. Shorts in two-year sterling positions were also closed. The fund remained short two-year German bunds. (Short positions are taken in the expectation that asset values will fall).

In September, the fund added emerging market debt in both the primary (Bulgaria, Romania) and secondary (Serbia) markets. In the following months, there was a swing toward selling hard currency emerging market debt. These included sales of bonds from Vietnam, Paraguay and Croatia. The fund added to holdings of local-currency emerging market debt, including Indonesia, Brazil and Peru.

More broadly, there were additions of sterling, yen and dollar bonds in November because of improved valuations. The fund also cut overall duration to almost a year underweight, relative to the Barclays Global Treasury index, in the final month of the year. Duration is a measure of exposure to changes in interest rates. December also saw increased exposure to the US dollar and Norwegian kroner, alongside reductions for the euro, New Zealand dollar, Singapore dollar and Korean won.

Outlook

Heading into 2023, inflation and the outlook for interest rates remain key drivers of global bond markets. Inflation is likely to remain elevated because of the ongoing fallout from Russia's invasion of Ukraine, and supply and demand disruptions following COVID-19 upheavals. However, the pace of price increases has cooled, helped by higher interest rates and an easing of fuel-price pressure. Improved access to alternative sources of energy, a relatively mild winter in Europe and power-saving efforts should all help to ease fuel-cost pressures, in our opinion.

The fund will maintain its disciplined investment approach in determining positions to best weather these market uncertainties. Strategy is driven by an assessment of global economic factors, which in turn helps to determine the fund's overall positioning and its holdings of individual bonds. This active management of allocations to both individual countries and different currencies will continue to provide the catalyst for long-term returns.

Notes to the financial statements

Accounting policies

The financial statements have been prepared in accordance with the 'Accounting policies' set out on page 5.

Distribution policy

In determining the amount available for distribution to Income shares, the annual charge is offset against capital, increasing the amount available for distribution whilst restraining capital performance to an equivalent extent.

For the purposes of these financial statements, the Prospectus dated 31 October 2022 has been used.

Investment objective

The fund aims to provide a higher total return (the combination of capital growth and income), net of the ongoing charge figure, than that of the FTSE All-Share Index over any five-year period.

Investment policy

At least 80% of the fund is invested directly in equity securities and equity-related securities of companies across any sectors and market capitalisations that are incorporated, domiciled, listed or do most of their business in the United Kingdom.

The fund may also invest in other transferable securities directly and via collective investment schemes (including funds managed by M&G).

The fund may also hold cash and near cash for liquidity purposes.

Derivatives may be used for efficient portfolio management and hedging.

Investment approach

The fund employs a disciplined approach to investment which concentrates on the analysis and selection of individual companies.

Recovery investing focuses on companies that have experienced difficulties but have the potential to deliver returns for shareholders through their turnaround over the long-term.

The fund looks to benefit from the market's inefficiency in valuing companies going through short-term challenges. This enables the fund manager to identify companies whose long-term prospects have been under-appreciated by the market.

When analysing a company, the fund manager focuses on three key factors: people, strategy and cashflow.

Developing a constructive dialogue with company management is fundamental to the investment process.

The investment approach means the fund manager is prepared to take a contrarian view and consider areas that are out of favour with other investors. To take this contrarian view, the fund manager focuses on company management, their turnaround strategy and the businesses' ability to generate cashflow.

The fund manager expects individual cases of companies recovering to be the main driver of performance rather than individual sectors and the macroeconomic environment.

The fund manager takes a long-term view with a typical holding period of five years or more.

Benchmark

Benchmark: FTSE All-Share Index.

The benchmark is a target which the fund seeks to outperform. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed.

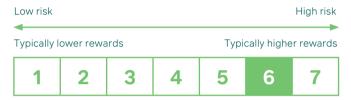

Investment review

For the six months ended 31 December 2022

Performance against objective

In the six months to 31 December 2022, Class 'A' Accumulation shares slightly lagged the index's 5.1% return. All other classes matched or bettered the benchmark. Over five years, the fund has lagged the FTSE All-Share Index's 2.9% pa total return (the combination of income and growth of capital) across all its share classes, therefore missing its objective.

For the performance of each share class, please refer to the 'Long-term performance by share class' table in the 'Financial highlights' section of this report.

Performance review

UK stocks made gains in the six months ended December 2022, with third-quarter losses more than offset by fourth-quarter gains. Shares fell in the three months to September amid economic worries, rising

interest rates and high inflation. Price increases were driven by energy costs following Russia's invasion of Ukraine.

UK asset values also slumped after the new government announced a fiscal package in September that sparked concerns about government borrowing. Bank of England (BoE) intervention steadied markets. The unwinding of the stimulus plan, and the replacement of Prime Minister Liz Truss with the more fiscally conservative Rishi Sunak, helped fuel a rebound in UK stocks in the last three months of the year. The BoE's move toward slowing the pace of rate increases also buoyed markets, along with optimism that the US Federal Reserve could potentially start cutting rates in late 2023.

Across the six-month review period, the FTSE 100 Index of large UK companies outperformed the mid-cap FTSE 250 Index and the FTSE Small Cap Index, both of which are more domestically focused. FTSE 100 members tend to be global businesses that benefit from a weak pound. Banks in the index were also boosted by rising interest rates, while high commodity prices aided miners and oil companies.

That market backdrop disadvantaged the fund in relative terms, as its holdings are skewed toward smaller businesses. FTSE 250 and FTSE Small Cap stocks make up about 35% of the portfolio, double the share for the benchmark. The fund has had a belowmarket exposure to FTSE 100 companies for many years. The fund has this make-up because many of the most undervalued and challenging situations are found in the mid-cap and small-cap segments. Over the longterm, it has benefited from holdings in smaller companies, even if this proved to be a drag on performance in the review period. Even so, the fund's holdings of large-caps and FTSE 250 members both outperformed due to good stock selection. Small cap selections underperformed.

BP was the fund's biggest return contributor in the period, helped by the oil company posting its biggest quarterly profit in 14 years. Software maker Micro Focus was another big contributor after a takeover offer, while

Beazley benefited from increased demand for cyber insurance. Rio Tinto gained as optimism about the easing of COVID-19 restrictions in China boosted ironore prices. Biotech Mesoblast rallied after nearing submission for US approval of a key product.

Telecommunications company BT was the fund's biggest negative return contributor amid labour disputes. Coach operator National Express also dragged on performance because of concerns about earnings and debt, as did medical device maker Creo Medical. Tullow Oil shares fell amid a failed merger attempt with Capricorn Energy, while shares in Mirriad Advertising slumped after the company missed revenue expectations.

Investment activities

The fund opened positions in betting companies Flutter and Entain in the third quarter amid falling share prices caused by the UK government's gambling review and a consumer spending slowdown. It also took part in a placing by an existing holding, medical technology company E-Therapeutics. Consumer health company Haleon joined the portfolio following its spin-off by drugmaker GSK.

Three positions were exited in the third quarter, including low-cost carrier EasyJet. Airlines face a difficult environment, which is compounded by dollar costs. The fund sold its stake in Dignity as the undertaker struggled with rising costs and a trend toward cheaper funerals. The position in Zinnwald Lithium was sold after the fund received stock as part of the company's takeover of Bacanora Lithium.

Fourth guarter additions included insurer Prudential, British Gas owner Centrica, clean-energy developer Ceres Power, and software company WANdisco. All these new positions were established on valuation grounds. The fund also moved to an above-index position in GSK as US court cases about the heartburn treatment Zantac offered a share revaluation opportunity. The fund's holding in consumer goods company Unilever was added to during the review period.

Exits in the final three months of the year included drugmaker Medical Developments International, wealth manager WH Ireland, and Associated British Foods, which owns the clothes retailer Primark. All three sales were due to better opportunities elsewhere. In addition, IWG was exited amid concerns over reduced demand for flexible office space during a recession. The fund also halved its Lloyds Banking position to pared back risk and trimmed its BP stake to avoid breaching a ceiling on individual holdings.

Of the four stages of the 'recovery' process for our companies (stage 1 - unloved; stage 2 - stabilising; stage 3 - recovering well; stage 4 - mature), the proportion of companies held in stage 1 remained around the same on balance as a number of businesses progressed to stage 2 (Direct Line and Moneysupermarket) and a number of new companies were bought. Several companies moved from the stabilising stage to 'recovering well' (stage 3). Only one holding - Watchstone - remained in stage 4.

Outlook

The key themes of 2022 are likely to continue into 2023. UK inflation remains above 10%, more interest rate increases seem likely, and there is little reason to expect a surge in economic growth. That likely favours global companies over more domestically-focused businesses, especially given the benefits of a weak pound and high commodity prices.

Authorised Corporate Director's Report

On a more positive note, the UK economy likely managed to avoid a recession in the second half of the year after a better-than-expected November. Inflation has started to cool from a very high base, and the BoE expects this to continue. Corporate balance sheets are also stronger than before the 2008 global financial crisis, which should help businesses weather demand slowdowns. The fund will continue to seek returns by identifying companies mispriced by the market given short-term challenges.

Notes to the financial statements

Accounting policies

The financial statements have been prepared in accordance with the 'Accounting policies' set out on page 5.

Distribution policy

In determining the amount available for distribution, ordinary stock dividends have been transferred to capital, reducing the amount available.

In determining the amount available for distribution to Income shares, the annual charge is offset against capital, increasing the amount available for distribution whilst restraining capital performance to an equivalent extent.

For the purposes of these financial statements, the Prospectus dated 31 October 2022 has been used.

Investment objective

The fund aims to deliver a higher total return (the combination of capital growth and income) than the Numis Smaller Companies Index (excluding Investment Companies), net of the ongoing charge figure, over any five year period.

Investment policy

At least 80% of the fund is invested in UK smaller companies. These are UK listed companies which, at the initial time of purchase, are:

- in the bottom 10% (by market capitalisation) of the FTSE All-Share index, or
- in the Numis Smaller Companies Index (excluding Investment Companies), or
- listed on the Alternative Investment Market.

The fund may also invest in collective investment schemes and other transferable securities. Cash and near cash may be held for ancillary purposes and derivatives, including warrants, may be used for efficient portfolio management and hedging purposes.

Investment approach

The fund manager takes a bottom-up approach to stockpicking and aims to construct a well-diversified portfolio. A long-term perspective is adopted with particular focus placed on 'growth drivers', competitive advantage, change, quality of management and valuation.

When a company held by the fund grows such that it no longer has the characteristics of a smaller company, the fund manager will reduce the holding in a manner and timescale best suited to meeting the fund's objective.

Benchmark

Benchmark: Numis Smaller Companies Index (excluding Investment Companies).

The benchmark is a target which the fund seeks to outperform. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used to measure the fund's performance and, together with the other index, and the Alternative Investment Market constrains the fund's portfolio construction as they define the investment universe of the fund.

The fund is actively managed.

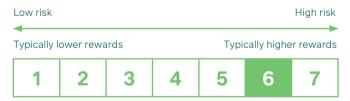

Investment review

For the six months ended 31 December 2022

Performance against objective

Between 1 July 2022 (the start of the review period) and 31 December 2022, the M&G Smaller Companies Fund delivered a positive total return (the combination of income and growth of capital) across all of its share classes. Fund performance was ahead of its benchmark, the Numis Smaller Companies Index (excluding Investment Companies), which returned 3.0% over the same period.

The fund met its investment objective of delivering a higher total return than the Numis Smaller Companies Index (excluding Investment Companies) over any fiveyear period for all share classes. The index returned 0.3% pa in the five years to 31 December 2022.

For the performance of each share class, please refer to the 'Long-term performance by share class' table in the 'Financial highlights' section of this report.

Performance review

Global stockmarkets were volatile over much of the past six months, with sentiment buffeted by soaring inflation, the prospect of higher interest rates and the ongoing war in Ukraine. There were significant political events in the UK too with the departure of two prime ministers and considerable disquiet over government policy approach leading to turmoil in financial markets and political U-turns.

The war in Ukraine shows no signs of ending in the near term and the global economic outlook has deteriorated markedly. This is partly due to economic sanctions and other measures against Russia by the West, as well as disruption to supply chains.

The opening of domestic and many other economies post COVID-related shutdowns have led to price rises, while constraints on gas supplies across Europe have sent energy prices soaring. Despite the weaker economic backdrop, worries about sharply rising inflation have led many central banks to raise interest rates. In the UK, interest rates stood at 3.5% at the end of December 2022.

In political developments, Prime Minister Boris Johnson lost the support of his MPs and Liz Truss became prime minister in early September. There followed a deeply unsettling period as the new prime minister sought to pursue her ambitious low-tax, pro-economic growth agenda, an unfunded plan that was badly received by financial markets

In a series of fast-moving events, the government then reversed most of its recently proposed measures, Liz Truss resigned in October and Rishi Sunak subsequently became prime minister. These developments were favourably received by the markets, which recovered much of the recent declines. In his Autumn Statement in November, Chancellor Jeremy Hunt announced tax rises and initial spending cuts as the government seeks to support the UK's finances.

Against this backdrop, more domestically focused smaller companies trailed their larger counterparts over the period under review as the latter generally have a greater international exposure.

In this environment, the fund made modest gains over the six-month period. The fund's performance was supported by sector allocation, with an above-index position in technology and a relatively light presence in real estate adding value. The fund's stock selection detracted slightly overall; stock picks in industrials, energy and consumer staples added value but selection in consumer discretionary and financials cost some performance.

The fund continued to benefit from takeover activity over the period, with notable contributions from environmental consultancy group RPS and collagen products manufacturer Devro. RPS, a large holding in the fund, received a takeover bid followed by a counter bid from a third party, while Devro received a takeover approach at a significant premium to its share price.

Oil services company Hunting was another major contributor as investors anticipate improved demand for energy production services, while Accesso Technology, which provides ticketing and queueing services for visitor attractions, benefited from better trading. Meanwhile, fund management consultancy

Alpha Financial Markets Consulting gained on the back of continued positive results.

In contrast, detractors included Inspecs, a provider of frames for spectacles, Watkin Jones, a developer of purpose-built student accommodation, and online gaming operator 888. Inspecs reported deteriorating trading, especially in Europe and investors became increasingly concerned about its debt levels and liquidity. Watkin Jones was hurt as some delayed asset transactions due to a transaction hiatus in the broader property market dented confidence in its short-term prospects. Meanwhile, investors were concerned about 888's high levels of borrowing. Not holding technology stock Micro Focus International also cost some performance as the stock benefited from a takeover bid.

Investment activities

We took the opportunity of attractive valuations to add a series of new holdings to the portfolio. For example, we added Workspace, a London-focused commercial office property owner, and Victrex, a high-performance polymer manufacturer, a good quality business. We also added oil and gas firm Serica Energy, engineering and consulting company Wood and Tullow Oil in order to boost a relatively light presence in energy as we believe prospects for the sector are encouraging for the foreseeable future.

We started a position in Wilmington, a business-tobusiness media company that has undergone a digital transition towards global compliance and regulation training in recent years. Other new positions included greetings card company Moonpig and Restaurant, a chain of restaurants and pubs. Moonpig is the leader in the online card market, which is expected to have very strong growth in the next five years. We feel Restaurant has market-leading brands that can take share in weaker markets whilst also having options to proactively reduce its debt should it need to do so. The management team has fixed energy costs beyond 2024 at rates substantially below recent market prices. We also started a position in market-leading healthcare technology company Craneware in the US. The company is close to finalising its transition to the cloud, which should accelerate revenue and earnings growth in the highly attractive US healthcare market.

Turning to disposals, a number of complete sales related to successful takeovers, namely healthcare software developer EMIS and RPS, mentioned earlier. We also sold construction companies Galliford Try and Kier, as we think the government is increasingly needed to scrutinise budgets and prioritise spending which may include infrastructure projects. We sold positions in law firm Knights and online retailer musicMagpie as we had lost conviction in the investment case for both stocks.

Outlook

Valuations in the small-cap universe are very attractive in our opinion and we anticipate continued bid interest in this sphere. We feel appealing valuations more than compensate for current heightened uncertainty in the market. While further profit warnings are to be expected, we are optimistic about the asset class for investors who are prepared to take a long-term view.

Notes to the financial statements

Accounting policies

The financial statements have been prepared in accordance with the 'Accounting policies' set out on page 5.

Distribution policy

In determining the amount available for distribution, ordinary stock dividends have been transferred to capital, reducing the amount available.

In determining the amount available for distribution to Income shares, the annual charge is offset against capital, increasing the amount available for distribution whilst restraining capital performance to an equivalent extent.

Other regulatory disclosures

Swiss investor information

For funds registered in Switzerland we are required by FINMA to disclose the Total Expense Ratio (TER).

For these funds the TERs are the same as the operating charges disclosed in the fund's financial highlights section under 'Performance and charges'.

Accumulation shares A type of share where distributions are automatically reinvested and reflected in the value of the shares.

Accumulation units A type of unit where distributions are automatically reinvested and reflected in the value of the units.

Asset Anything having commercial or exchange value that is owned by a business, institution or individual.

Asset allocation Apportioning a portfolio's assets according to risk tolerance and investment goals.

Asset class Category of assets, such as cash, company shares, fixed income securities and their sub-categories, as well as tangible assets such as real estate.

Bond A loan in the form of a security, usually issued by a government or company, which normally pays a fixed rate of interest over a given time period, at the end of which the initial amount borrowed is repaid.

Bond issue A set of fixed income securities offered for sale to the public by a company or government. If the bonds are sold for the first time, it is called a 'new issue'.

Bottom-up selection Selecting stocks based on the attractiveness of a company.

Bunds Fixed income securities issued by the German government.

Capital Refers to the financial assets, or resources, that a company has to fund its business operations.

Capital growth Occurs when the current value of an investment is greater than the initial amount invested.

Capital return The term for the gain or loss derived from an investment over a particular period. Capital return includes capital gain or loss only and excludes income (in the form of interest or dividend payments).

Cash equivalents Deposits or investments with similar characteristics to cash.

Charity Authorised Investment Fund (CAIF) An investment entity that is both a registered charity and an authorised investment fund. The CAIF must comply with charity law as well as financial services laws and regulations, and is usually treated as a registered charity for tax purposes.

Comparative sector A group of funds with similar investment objectives and/or types of investment, as classified by bodies such as the Investment Association (IA) or Morningstar™. Sector definitions are mostly based on the main assets a fund should invest in, and may also have a geographic focus. Sectors can be the basis for comparing the different characteristics of similar funds, such as their performance or charging structure.

Consumer Prices Index (CPI) An index used to measure inflation, which is the rate of change in prices for a basket of goods and services. The contents of the basket are meant to be representative of products and services we typically spend our money on.

Convertible bonds Fixed income securities that can be exchanged for predetermined amounts of company shares at certain times during their life.

Corporate bonds Fixed income securities issued by a company. They are also known as bonds and can offer higher interest payments than bonds issued by governments as they are often considered more risky.

Coupon The interest paid by the government or company that has raised a loan by selling bonds.

Credit The borrowing capacity of an individual, company or government. More narrowly, the term is often used as a synonym for fixed income securities issued by companies.

Credit default swaps (CDS) Are a type of derivative, namely financial instruments whose value, and price, are dependent on one or more underlying assets. CDS are insurance-like contracts that allow investors to transfer the risk of a fixed income security defaulting to another investor.

Credit rating An independent assessment of a borrower's ability to repay its debts. A high rating indicates that the credit rating agency considers the issuer to be at low risk of default; likewise, a low rating indicates high risk of default. Standard & Poor's, Fitch and Moody's are the three most prominent credit rating agencies. Default means that a company or government is unable to meet interest payments or repay the initial investment amount at the end of a security's life.

Credit rating agency A company that analyses the financial strength of issuers of fixed income securities and attaches a rating to their debt. Examples include Standard & Poor's and Moody's.

Credit risk Risk that a financial obligation will not be paid and a loss will result for the lender.

Credit selection The process of evaluating a fixed income security, also called a bond, in order to ascertain the ability of the borrower to meet its debt obligations. This research seeks to identify the appropriate level of default risk associated with investing in that particular bond.

Credit spread The difference between the yield of a corporate bond, a fixed income security issued by a company, and a government bond of the same life span. Yield refers to the income received from an investment and is expressed as a percentage of the investment's current market value.

Default When a borrower does not maintain interest payments or repay the amount borrowed when due.

Defaulted bond When a bond issuer does not maintain interest payments or repay the amount borrowed when due.

Default risk Risk that a debtholder will not receive interest and full repayment of the loan when due.

Derivatives Financial instruments whose value, and price, are dependent on one or more underlying assets. Derivatives can be used to gain exposure to, or to help protect against, expected changes in the value of the underlying investments. Derivatives may be traded on a regulated exchange or traded over the counter.

Developed economy/market Well-established economies with a high degree of industrialisation, standard of living and security.

Dilution adjustments The dilution adjustment is used to protect ongoing investors against the transaction charges incurred in investing or divesting in respect of creations and cancellations. The dilution adjustment is made up of the direct and indirect transaction charges. In the financial statements the direct transaction charges as a percentage of average NAV will be disclosed. This percentage will take account of those direct transaction charges that have been recovered through the dilution adjustment leaving a percentage that just represents the costs incurred in portfolio management.

Distribution Distributions represent a share in the income of the fund and are paid out to Income shareholders or reinvested for Accumulation shareholders at set times of the year (monthly, quarterly, half-yearly or annually). They may either be in the form of interest distributions or dividend distributions.

Distribution yield Expresses the amount that is expected to be distributed by the fund over the next 12 months as a percentage of the share price as at a certain date. It is based on the expected gross income less the ongoing charges.

Diversification The practice of investing in a variety of assets. This is a risk management technique where, in a welldiversified portfolio, any loss from an individual holding should be offset by gains in other holdings, thereby lessening the impact on the overall portfolio.

Dividend Dividends represent a share in the profits of a company and are paid out to the company's shareholders at set times of the year.

Duration A measure of the sensitivity of a fixed income security, also called a bond, or bond fund to changes in interest rates. The longer a bond or bond fund's duration, the more sensitive it is to interest rate movements.

Duration risk The longer a fixed income security, also called a bond, or bond fund's duration, the more sensitive and therefore at risk it is to changes in interest rates.

Emerging economy or market Economies in the process of rapid growth and increasing industrialisation. Investments in emerging markets are generally considered to be riskier than those in developed markets.

Equities Shares of ownership in a company.

Exchange traded Usually refers to investments traded on an exchange, such as company shares on a stock exchange.

Ex-dividend, ex-distribution or XD date The date on which declared distributions officially belong to underlying investors.

Exposure The proportion of a fund invested in a particular share/fixed income security, sector/region, usually expressed as a percentage of the overall portfolio.

Fixed income security A loan in the form of a security, usually issued by a government or company, which normally pays a fixed rate of interest over a given time period, at the end of which the initial amount borrowed is repaid. Also referred to as a bond.

Floating rate notes (FRNs) Securities whose interest (income) payments are periodically adjusted depending on the change in a reference interest rate.

Foreign exchange The exchange of one currency for another, or the conversion of one currency into another currency. Foreign exchange also refers to the global market where currencies are traded virtually around the clock. The term foreign exchange is usually abbreviated as 'forex' and occasionally as 'FX'.

Foreign exchange (FX) strategy Currencies can be an asset class in its own right, along with company shares, fixed income securities, property and cash. Foreign exchange strategy can therefore be a source of investment returns.

Forward contract A contract between two parties to buy or sell a particular commodity or financial instrument at a predetermined price at a future date. Examples include forward currency contracts.

Fundamentals (company) A basic principle, rule, law, or the like, that serves as the groundwork of a system. A company's fundamentals pertain specifically to that company, and are factors such as its business model, earnings, balance sheet and debt.

Fundamentals (economic) A basic principle, rule, law, or the like, that serves as the groundwork of a system. Economic fundamentals are factors such as inflation, employment, economic growth.

Futures A futures contract is a contract between two parties to buy or sell a particular commodity or financial instrument at a predetermined price at a future date. Futures are traded on a regulated exchange.

Gilts Fixed income securities issued by the UK government.

Government bonds Fixed income securities issued by governments, that normally pay a fixed rate of interest over a given time period, at the end of which the initial investment is repaid.

Hedging A method of reducing unnecessary or unintended

High water mark (HWM) The highest level that a fund's NAV (net asset value) has reached at the end of any 12-month accounting period.

High yield bonds Fixed income securities issued by companies with a low credit rating from a recognised credit rating agency. They are considered to be at higher risk of default than better quality, i.e. higher-rated fixed income securities but have the potential for higher rewards. Default means that a company or government is unable to meet interest payments or repay the initial investment amount at the end of a security's life.

Historic yield The historic yield reflects distributions declared over the past 12 months as a percentage of the share price, as at the date shown.

Income yield Refers to the income received from an investment and is usually expressed annually as a percentage based on the investment's cost, its current market value or face value

Index An index represents a particular market or a portion of it, serving as a performance indicator for that market.

Income shares A type of share where distributions are paid out as cash on the payment date.

Income units A type of unit where distributions are paid out as cash on the payment date.

Index tracking A fund management strategy that aims to match the returns from a particular index.

Index-linked bonds Fixed income securities where both the value of the loan and the interest payments are adjusted in line with inflation over the life of the security. Also referred to as inflation-linked bonds.

Inflation The rate of increase in the cost of living. Inflation is usually quoted as an annual percentage, comparing the average price this month with the same month a year earlier.

Inflation risk The risk that inflation will reduce the return of an investment in real terms.

Initial public offering (IPO) The first sale of shares by a private company to the public.

Interest rate risk The risk that a fixed income investment will lose value if interest rates rise.

Interest rate swap An agreement between two parties to swap a fixed interest payment with a variable interest payment over a specified period of time.

Investment Association (IA) The UK trade body that represents fund managers. It works with investment managers, liaising with government on matters of taxation and regulation, and also aims to help investors understand the industry and the investment options available to them.

Investment grade bonds Fixed income securities issued by a company with a medium or high credit rating from a recognised credit rating agency. They are considered to be at lower risk from default than those issued by companies with lower credit ratings. Default means that a company or government is unable to meet interest payments or repay the initial investment amount at the end of a security's life.

Issuer An entity that sells securities, such as fixed income securities and company shares.

Leverage When referring to a company, leverage is the level of a company's debt in relation to its assets. A company with significantly more debt than capital is considered to be leveraged. It can also refer to a fund that borrows money or uses derivatives to magnify an investment position.

Liquidity A company is considered highly liquid if it has plenty of cash at its disposal. A company's shares are considered highly liquid if they can be easily bought or sold since large amounts are regularly traded.

Long position Refers to ownership of a security held in the expectation that the security will rise in value.

Macroeconomic Refers to the performance and behaviour of an economy at the regional or national level. Macroeconomic factors such as economic output, unemployment, inflation and investment are key indicators of economic performance. Sometimes abbreviated to 'macro'.

Maturity The length of time until the initial investment amount of a fixed income security is due to be repaid to the holder of the security.

Modified duration A measure of the sensitivity of a fixed income security, called a bond, or bond fund to changes in interest rates. The longer a bond or bond fund's duration, the more sensitive it is to interest rate movements.

Monetary easing When central banks lower interest rates or buy securities on the open market to increase the money in circulation.

Monetary policy A central bank's regulation of money in circulation and interest rates.

Monetary tightening When central banks raise interest rates or sell securities on the open market to decrease the money in

Morningstar™ A provider of independent investment research, including performance statistics and independent fund ratings.

Near cash Deposits or investments with similar characteristics to cash.

Net asset value (NAV) A fund's net asset value is calculated by taking the current value of the fund's assets and subtracting its liabilities.

Ongoing Charge Figure The ongoing charge figure represents the operating costs investors can reasonably expect to pay under normal circumstances.

Open-ended investment company (OEIC) A type of managed fund, whose value is directly linked to the value of the fund's underlying investments.

Options Financial contracts that offer the right, but not the obligation, to buy or sell an asset at a given price on or before a given date in the future.

Over-the-counter (OTC) Whereby financial assets are traded directly between two parties. This is in contrast to exchange trading, which is carried out through exchanges set up specifically for the purpose of trading. OTC is also known as off-exchange trading.

Overweight If a fund is 'overweight' a stock, it holds a larger proportion of that stock than the comparable index or sector.

Payment date The date on which distributions will be paid by the fund to investors, usually the last business day of the month.

Physical assets An item of value that has tangible existence, for example, cash, equipment, inventory or real estate. Physical assets can also refer to securities, such as company shares or fixed income securities.

Portfolio transaction cost The cost of trading, such as brokerage, clearing, exchange fees and bid-offer spread as well as taxes such as stamp duty.

Preference shares Preference shares are a loan to a company that may be traded in the same way as ordinary shares, but generally have a higher yield and pay dividends on fixed dates. Preference shares have varying characteristics as to the treatment of the principal and the dividend payment, which includes ranking them above ordinary shares when it comes to dividend payments.

Principal The face value of a fixed income security, which is the amount due back to the investor by the borrower when the security reaches the end of its life.

Private placement An offer of sale of securities to a relatively small number of investors selected by the company, generally investment banks, mutual funds, insurance companies or pension funds.

Property Expense Ratio (PER) Property expenses are the operating expenses that relate to the management of the property assets in the portfolio. These include: insurance and rates, rent review and lease renewal costs and maintenance and repairs, but not improvements. They depend on the level of activity taking place within the fund. The Property Expense Ratio is the ratio of property expenses to the fund's net asset value.

Real yield The return of an investment, adjusted for changes in prices in an economy.

Retail Prices Index (RPI) A UK inflation index that measures the rate of change in prices for a basket of goods and services in the UK, including mortgage payments and council tax.

Risk The chance that an investment's return will be different to what is expected. Risk includes the possibility of losing some or all of the original investment.

Risk management The term used to describe the activities the fund manager undertakes to limit the risk of a loss in a fund.

Risk premium The difference between the return from a riskfree asset, such as a high-quality government bond or cash, and the return from an investment in any other asset. The risk premium can be considered the 'price' or 'pay-off' for taking on increased risk. A higher risk premium implies higher risk.

Risk-free asset An asset that notionally carries no risk of nonpayment by the borrower such as a high-quality fixed income security issued by a government or cash.

Risk/reward ratio A ratio comparing the expected returns of an investment with the amount of risk undertaken.

Safe-haven assets Refers to assets that investors perceive to be relatively safe from suffering a loss in times of market turmoil.

Security Financial term for a paper asset – usually a share in a company or a fixed income security also known as a bond.

Share class Each M&G fund has different share classes, such as A, R and I. Each has a different level of charges and minimum investment. Details on charges and minimum investments can be found in the Key Investor Information Documents.

Share class hedging Activities undertaken in respect of hedged shares to mitigate the impact on performance of exchange rate movements between the fund's currency exposure and the investor's chosen currency.

Short position A way for a fund manager to express his or her view that the market might fall in value.

Short selling This often refers to the practice whereby an investor sells an asset they do not own. The investor borrows the asset from someone who does own it and pays a fee. The investor must eventually return the borrowed asset by buying it in the open market. If the asset has fallen in price, the investor buys it for less than they sold it for, thus making a profit. The contrary may also occur.

Short-dated corporate bonds Fixed income securities issued by companies and repaid over relatively short periods.

Short-dated government bonds Fixed income securities issued by governments and repaid over relatively short periods.

Sovereign debt Debt of a government. Also referred to as government bonds.

Sub-investment grade bonds Fixed income securities issued by a company with a low rating from a recognised credit rating agency. They are considered to be at higher risk from default than those issued by companies with higher credit ratings. Default means that a company or government is unable to meet interest payments or repay the initial investment amount at the end of a security's life.

Suspended Temporarily halting the trading of a listed security on the stock exchange. It can be voluntary (requested by the issuing company) or imposed by regulators. Typically, trading suspensions are introduced ahead of important news announcements, following technical glitches, or due to regulatory concerns.

Swing pricing Swing pricing is a method of protecting longterm shareholders in the fund from bearing the costs of transactions carried out by shorter-term investors. When investors buy or sell shares in the fund, the fund manager has to buy or sell underlying securities to either invest the cash obtained from investors, or to provide them with cash in exchange for their shares. Swing pricing essentially adjusts the fund shares' daily price to take into account the costs of buying or selling the underlying securities held by the fund. This ensures that transaction costs such as brokerage fees and administrative charges are borne by those investors who trade shares in the fund, not by those who remain invested in the fund. (Also see dilution adjustment).

Top-down investing An investment approach that analyses economic factors, ie surveys the 'big picture', before selecting which companies to invest in. The top-down investor will look at which industries are likely to generate the best returns in certain economic conditions and limit the search to that area.

Total return The term for the gain or loss derived from an investment over a particular period. Total return includes income (in the form of interest or dividend payments) and capital gains.

Treasuries Fixed income securities issued by the US government.

Triple A or AAA rated The highest possible rating a fixed income security, also called a bond, can be assigned by credit rating agencies. Bonds that are rated AAA are perceived to have the lowest risk of default. Default means that a company or government is unable to meet interest payments or repay the initial investment amount at the end of a security's life.

UCITS Stands for Undertakings for Collective Investment in Transferable Securities. This is the European regulatory framework for an investment vehicle that can be marketed across the European Union and is designed to enhance the single market in financial assets while maintaining high levels of investor protection.

Unconstrained The term used to describe the mandate of a fund whereby the manager has the freedom to invest according to his or her own strategy, not being obliged to allocate capital according to the weightings of any index, for example.

Underlying value The fundamental value of a company, reflecting both tangible and intangible assets, rather than the current market value.

Underlying yield Refers to the income received by a managed fund, and is usually expressed annually as a percentage based on the fund's current value.

Underweight If a portfolio is 'underweight' a stock, it holds a smaller proportion of that stock than the comparable index or sector.

Unit trust A type of managed fund, whose value is directly linked to the value of the fund's underlying investments.

Unit/share type Type of units/shares held by investors in a trust or fund (unit/share types differ by features such as whether income is to be paid out as cash or reinvested on the payment date).

Unlisted/unquoted stocks Shares of ownership in companies that are not listed on a public exchange, known as private

Valuation The worth of an asset or company based on its current price.

Volatile When the value of a particular share, market or sector swings up and down fairly frequently and/or significantly, it is considered volatile.

Volatility The degree to which a given security, fund, or index rapidly changes. It is calculated as the degree of deviation from the norm for that type of investment over a given time period. The higher the volatility, the riskier the security tends

Warrant A security issued by a company that gives the holder the right to buy shares in that company at a specified price and within a certain timeframe.

Yield This refers to either the interest received from a fixed income security or to the dividends received from a share. It is usually expressed as a percentage based on the investment's costs, its current market value or its face value. Dividends represent a share in the profits of the company and are paid out to a company's shareholders at set times of the year.

Yield (equity) Refers to the dividends received by a holder of company shares and is usually expressed annually as a percentage based on the investment's cost, its current market value or face value. Dividends represent a share in the profits of the company and are paid out to a company's shareholders at set times of the year.

Yield (bonds) This refers to the interest received from a fixed income security and is usually expressed annually as a percentage based on the investment's cost, its current market value or its face value.

Yield (income) Refers to the income received from an investment and is usually expressed annually as a percentage based on the investment's cost, its current market value or face value.
