### **Objectives and investment policy**

#### Objective

To provide a return, through a combination of capital growth and income, net of fees, over the long-term (at least five years).

#### Policy

At least 70% of the Fund is invested in collective investment schemes (including funds managed by Jupiter or an associate of Jupiter). These schemes may have exposure to shares of companies globally, fixed interest securities, derivatives (including for investment purposes), commodities or property. The Fund will typically have exposure (direct and/or indirect) of at least 80% to shares of companies.

Up to 30% of the Fund may be invested in other transferable securities such as exchange traded commodities, cash, near cash, money market instruments and deposits.

The Fund may use derivatives (i.e. financial contracts whose value is linked to the expected price movements of an underlying investment) with the aim of reducing the overall costs and/or risks of the Fund.

#### Strategy

The team believes that with deep and thorough research, they are able to identify active fund managers with the ability to generate strong risk-adjusted returns.

The Fund will tend to invest in a focused portfolio of funds where the manager has the highest conviction.

### **Risk and reward profile**

- The lowest category does not mean 'no risk'.
- The Fund is in this category due to the nature of its investments and previous levels
  of volatility (how much the value of the Fund rises and falls).
- Currency (FX) Risk The Fund can be exposed to different currencies and movements in foreign exchange rates can cause the value of investments to fall as well as rise.
- Pricing Risk Price movements in financial assets mean the value of assets can fall as well as rise, with this risk typically amplified in more volatile market conditions.
- Derivative risk the Fund may use derivatives to reduce costs and/or the overall risk of the Fund (this is also known as Efficient Portfolio Management or "EPM"). Derivatives involve a level of risk, however, for EPM they should not increase the overall riskiness of the Fund.
- **Counterparty Risk** the risk of losses due to the default of a counterparty e.g. on a derivatives contract or a custodian that is safeguarding the Fund's assets.

This is a risk-based index, which has 80%-110% relative risk to world equities. It is a fair representation of the risk-adjusted return which might be achieved by the Fund and as such it is an appropriate comparator benchmark.

#### **Active Management**

The Fund is actively managed. This means the fund manager is taking investment decisions with the intention of achieving the Fund's investment objective; this may include decisions regarding asset selection, regional allocation, sector views and overall level of exposure to the market.

Any income arising in relation to this unit class will be distributed to investors on a regular basis.

Investors are able to buy and sell units during any business day between 9am and 5.30pm. If you tell us to buy or sell units before 12pm on any business day we will make the transaction on the same day. If you tell us to buy or sell units after 12pm we will make the transaction on the following business day.

This fund may not be suitable for investors who plan to withdraw their capital within 5 years.


